ORDER

KSEB_had accorded sanction as per the B.O read as 1st above for executing an agreement with PGCIL for carrying out the O&M of terminal equipments of PGCIL bays at 220 kV Substation, Pallom after excluding the O&M of terminal equipments of the Edamon-Kundara and Edamon-Edappon bays at 220 kV Substation, Edamon.

However, in the decision part of the order (Decision No.1), the name of the substation was mistakenly written as "Edappon" instead of "Edamon" due to typographical error. The matter was placed before the Full Time Directors as per the note read as 2 nd above, for issuing an errata order.

Having considered the matter in detail, the Full Time Directors in the meeting held on 22.07.2022 resolved to modify the decision in Point No.1 of the B.O. (FTD) No. 530/2022 (DIRTSO-AEE5/2022/1117 dated 21.06.2022 as follows:

"To execute the agreement with PGCIL for carrying out the O & M of terminal equipments of PGCIL bays at 220 kV Substation, Pallom for a further period of 10 years with effect from 01.11.2018, after excluding the O & M of Edamon-Kundara bay and Edamon-Edappon bay at 220 kV Substation, Edamon with effect from 22.06.2018 and 01.07.2018 respectively". Orders are issued accordingly.
