ORDER

As per the BO read as 1st above, a Market Monitoring Group (MMG) had been constituted with the Officers from Commercial, TRAC, Planning, SCADA & Audit wing for day to day monitoring and reporting of developments in power procurement and management.

The members of the group are to carry out the following responsibilities in addition to their normal duties.

- i. Daily monitoring vis —a vis predicted /planned figures of the
 - a. Demand (MW) & Consumption (MU)
 - b. Power availability from various sources
 - c. Demand and Supply Mismatches
- d. Hydro storage, weather predictions, rainfall, inflow, hydro generation
- e. Price discovered in DEEP portal for short term, power exchanges on day ahead/contingency/term ahead basis
- f. Preparing mock bids and review the bids placed by the Board in the day ahead market and make recommendations to the Board.
- g. Mapping of power /energy surplus/deficit period in other states for efficient banking of power
- Monitoring of the surplus/deficit period in other states for efficient banking of power.
- iii. Make suggestions on optimizing the internal generation and on opportunistic sale/purchase/banking of power in a financially prudent manner.

As part of getting promotions/transfers and different work allocation to the members of the group, the Chief Engineer (Commercial & Tariff) as per the note read as 3rd above had reported that the MMG was not functioning to the extend it was meant to be. Hence, had recommended for reconstituting the Committee with those officers who are presently working in areas where, they can contribute much to the expected output of MMG.
