The order of the State Electricity Ombudsman was placed before the Full Time Directors as per note read as 4th above. Having examined the matter in detail the Full Time Directors in its meeting held on 15.07.2022 and resolved to assign LT IVB tariff against Consumer No.16914 (Marunadan Malayali) till 25.06.2022 in compliance of the order dated 11.11.2021 of the Electricity Ombudsman in Appeal Petition No.P/038/2021 and thereafter to re-assign the tariff of the consumer under LT VI F with effect from 26.06.2022 in accordance with the tariff order dated 26.06.2022.
