ORDER

Government of India, in its aim for providing 24x7 uninterrupted, quality, reliable and affordable power supply, has formulated the Revamped Distribution Sector Scheme (RDSS) under the Ministry of Power for supporting DISCOMs to undertake reforms and improve performance in a time bound manner.

The Monitoring Committee for RDSS constituted under Chairmanship of Secretary (Power), Government of India, in its 7th meeting held on 15.03.2022, approved the Action plan and DPRs for Loss Reduction works and Smart metering submitted by KSEBL for a total amount of ₹10475.03 Crores. The sanctioned project cost includes the amount for Smart System metering (₹8205.71 Crore) and Infrastructure-Loss Reduction Works (₹2235.78 Crore) for KSEB, Cochin Port Trust (now renamed as Cochin Port Authority) and also the works proposed under Modernisation for three SCADA/DMS Towns - Thrissur, Kollam & Kannur including its supporting infrastructure work - UG Cabling & 11 kV feeder outlets.

RDSS guidelines issued by MoP stipulates that, one or more Project Management agency shall be appointed by each DISCOM for project formulation and project management, based on their requirement to cover different phases of the project. The scope of PMA includes preparation of plan, DPR, tender documents, awarding, monitoring, quality assurance, material inspection, results evaluation or any other related work. As per the terms and conditions of the sanction letter received from Power Finance Corporation Ltd (Nodal Agency for RDSS) read as 1st above, KSEBL is to appoint Project Management Agency (ies) through Tendering in line with the Standard Bidding Document (SBD).

The total proposal for Infrastructure works (Distribution & Sub Transmission) for the sanctioned Loss reduction works and Modernization works (sanction expected) in KSEBL (including Cochin Port Authority) comes to ₹3120 Crore which excludes the IT-OT & SCADA portion and thus the PMA charges comes to approximately ₹45 Crores (ie, 1.5% of ₹3120 Crores). Government Budgetary Support is restricted to 60% of Sanction Cost. The tender for the appointment of PMA was invited as per tender read as 2nd above. Two bids received were opened on 01.06.2022. The technical evaluation of the bids by the evaluation Committee constituted as per B.O. read 3rd above is under progress and clarifications on the documents submitted have been sought from the bidders.

As per the conditions of Standard Bidding Document (Clause 22.1), the technical evaluation of the bids is to be approved by competent authority before opening the Financial bids. Hence, a Pre-Qualification Committee is to be formulated for prequalifying the firms and the financial bids of only those prequalified firms will be opened.

The Chief Engineer (IT,CR&CAPS) had recommended to constitute a Pre-Qualification Committee for the tender, for appointment of Project Management Agency for System Infrastructure works under RDSS in KSEBL, consisting of the following members.
