ABSTRACT

Allocation of a new vehicle / hiring a vehicle on contract for the official use of the Deputy Chief Engineer (PED) with full powers of the Chief Engineer - Sanctioned - Orders Issued

ORDER

As per the Board Order read as 1st above, it was decided to bifurcate the present dual function of the Chief Engineer (Generation & PED) as Generation and PED wings and to delegate the Deputy Chief Engineer (PED) with full powers of the Chief Engineer (PED). The Deputy Chief Engineer (PED) with full powers of Chief Engineer as per the Note read as 2nd above has reported the non-availability of an official vehicle for performing the official duties and hence requested sanction for the allocation of a new vehicle for official purpose.

The Deputy Chief Engineer (PED) with full Powers of the Chief Engineer has to perform frequent trips State wide to various project sites including hilly terrains for monitoring the progress of works of these stations. Since the works related to various ongoing Small and large Hydro Electric Projects are under execution on a war footing basis, a new vehicle particularly suitable for use in hilly terrain is recommended for the official use of the Deputy Chief Engineer (PED).

Considering the location of Power Houses and Project Sites and the necessity of a vehicle for the timely monitoring of various works related to the smooth functioning of these Projects, it was recommended for allocation of a new vehicle for the official use of the Deputy Chief Engineer (PED) with full Powers of the Chief Engineer for performing his official duties. The matter was placed before the Full Time Directors as per the Note read as 3rd above and it was directed to submit the note with an estimate.

In the above circumstances, revised note read as 5th above was submitted seeking sanction for a contract vehicle (Sedan type A/C car) instead of a new one. Considering the expenditure expected for the procurement of a new vehicle and by comparing that of a contract vehicle, it is recommended for hiring a vehicle (Sedan type A/C car) on contract basis for the official use of the Deputy Chief Engineer (PED) with full Powers of the Chief Engineer for performing his official duties with kilometer ceiling as specified in the prevailing orders in this regard.

The matter was placed before the Full Time Directors as per paper read as 5th above.

Having considered the matter in detail, the Full Time Directors in the meeting held on 07.07.2022 resolved to accord sanction for hiring a vehicle (Sedan type A/C car) on contract basis for the official use of Deputy Chief Engineer (PED) with full powers of Chief Engineer with kilometer ceiling as per prevailing orders in this regard.

Further resolved to authorize the Secretary (Administration) to do the needful.

Orders are issued Accordingly.
