· ORDER

A bid for the Selection of Wind Power Developers for Setting up of 100MW Grid-connected Wind Power Projects in Kerala under Tariff Based Competitive Bidding- Build, Own and operate model for a period of 25 years was floated from the office of the Chief Engineer (REES) &CSC, as per tender read as 1st above. The Technical bid was opened on 15.03.2022. The following four bidders had submitted Technical bids.

- 1) M/s.Scoobee Day Garments(INDIA) Limited
- 2) M/s.Aban Green Power Private Limited
- 3) M/s. INKEL Limited
- 4) M/s. Pioneer Wincon Energy Systems Private Limited

Subsequently, the bid evaluation committee constituted as per the Office order read as 2nd above, decided to prequalify all the above 4 bidders and the price bid was opened on 23.04.2022. The details of tariff offered are given below:

As per the discussions regarding tariff negotiation, held in the chamber of the Director (REES,SOURA,S&W) on 04.05.2022 and by the Chairman and Managing Director, KSEBL on 13.05.2022, the remaining three bidders were requested to reduce the tariff to the L1 price(Rs.3.96/kWh). The bidders submitted the final price as shown below.

In these circumstances, the Full Time Directors, in its meeting held on 13.06.2022

- 1. Resolved to issue a letter of Award to M/s. Aban Green Power Private Limited, L1 at Rs. 3.96/ kWh for the 10 MW wind power project at their proposed site at Tyford Tea Estate, Elappara, Idukki.
- 2. Further resolved to issue LoA at the L2 rate Rs. 4.09/ kWh to the following bidders also in view of the need of quantum of RPO on bucket filling basis.

Having considered the matter in detail, the Director Board meeting held on 29.06.2022 resolved to ratify the action taken on the decision of the Full Time Directors vide B.O read as 3rd above to issue 4 Nos LoA to the following qualified bidders towards 35.5MW wind power development in Kerala subject to KSERC approval.
