## ABSTRACT

Supply of thermal paper rolls to the Distribution Circle offices/SRS with advertisement printed on the back side - Selection of bidder M/s Aceware Fintech Services Pvt Ltd - Sanctioned - Orders issued.

## ORDER

KSEBL as per B.O. read as 1st above, has accorded sanction for printing advertisement on the back side of the thermal paper used for printing electricity bills and had authorized the Chief Engineer (IT, CR & CAPs) to invite an EOI for the same. Accordingly, EOI was invited and order for the supply of thermal paper rolls at Electrical Circle Offices located at Thiruvananthapuram, Kollam, Kottayam, Alappuzha, Ernakulam and Kozhikode was awarded to M/s.Silver Campaigns. Further RFP read as 2nd above for the supply of thermal paper rolls for printing electricity bills, with advertisement printed on the backside, to the other eight districts - Pathanamthitta, Idukki, Thrissur, Palakkad, Malappuram, Kannur, Kasargod and Wayanad was invited. A single bidder M/s. Aceware Fintech Services Pvt Ltd participated in the bid and the firm offered to supply 56,000 thermal paper rolls per month free of cost with their own advertisement printed on the back side of the paper, with an additional premium of ₹2/-per thermal roll.

Meanwhile, the period of contract with M/s Silver campaigns Ltd, for the supply of thermal paper rolls to six districts had ended and they were not willing to extent the contract period. On enquiry, M/s Aceware Fintech Services Pvt Ltd, as per e-mail read as 3rd above has expressed willingness to supply additional rolls of 60,000 (Sixty Thousand) thermal paper rolls per month to the six districts which was not covered in the RFP read as 2nd above, at the same terms and conditions of their offer.

The matter was placed before the Full Time Directors, as per the Note read as 4th above. Having considered the matter in detail, the Full time directors in its meeting held on 27.06.2022, Resolved to accord sanction for the following

1. To select the single bidder, M/s. Aceware Fintech Services Pvt Ltd for supplying predetermined quantity of thermal paper rolls with KSEBL approved advertisements printed on the blank space on the back side of the thermal paper used for printing electricity bills, at various Circle offices situated at different parts of the state.

- 2. To allow the selected bidder to deliver the thermal paper roll, used in the spot billing machines to various Circle offices/SRS situated at different parts of the state.
- To authorize the Chief Engineer (IT, CR & CAPs) to issue work order, approve the advertisement matter to be printed on the thermal paper rolls and execute agreement with M/s. Aceware Fintech Services Pvt Ltd.
- 4. To authorize the Chief Engineer (IT, CR & CAPs) to collect the advertisement fee (premium charges) monthly from the firm based on the invoice raised by the Chief Engineer (IT, CR & CAPs).

Orders are issued accordingly.
