## ABSTRACT

Supply of 8M long 410 SP-11 swaged type galvanized steel Tubular Poles to various Electrical Circles under Kerala State Electricity Board Limited — Urgent Procurement — to meet the emergency requirement — Ratification for procurement — Sanctioned - Orders issued.

## ORDER

With reference to the minutes of meeting read as 1,above, the Chairman and Managing Director, KSEBL, has directed to procure good quality steel Tubular Poles, with stepper facility to supplement the availability of poles urgently and to meet the emergency situation arising out of natural calamity, during the monsoon period. It was directed to procure 100 tubular poles each for section offices under North Malabar Region, Pathanamthitta and Thodupuzha Electrical Circles and 30 poles each for section offices in other areas.

As per the enquiries made with certain suppliers from North India through India MART, on 21/04/2022, and the estimated rate obtained from the Deputy Chief Engineer, Civil Circle, Pallom,(in charge of all manufacturing units of KSEBL), the tentative rates were arrived at, as Rs,17,500/- per pole, including 18% GST.

Hence for 776 section offices, 100 tubular poles each for section offices under North Malabar Region, Pathanamthitta and Thodupuzha Electrical Circles and 30 poles each for section offices in other areas will require 42670 Tubular poles amounting to Rs. 74,67, 25,000/-.

In order to get the tubular poles without much delay due to the limited manufacturing capacity of firms (maximum 5000 poles per month), and to meet the calamity requirements in near future, the quantity was subsequently limited to 13300 Nos, at an estimated total PAC of Rs.23,27,50,000/- .( i.e 30 tubular poles each for section offices under North Malabar Region, Pathanamthitta and Thodupuzha Electrical Circles and 10 poles each for section offices in other areas) taking into consideration sufficient availability of 8m/200kg PSC Poles in the coming months.

In the note read as 2<sup>nd</sup> above, the Chairman and Managing Director, KSEBL, has directed to float the tender first and to get ratification from the Full Time Directors for the same.

Hence as per tender read as 3<sup>rd</sup> above, e- tender was floated for 13300 Nos. of 410 SP-11-8M long swaged type galvanized steel Tubular Poles at a total PAC of Rs.23,27,50,000/-including GST (Rupees Twenty three Crore Twenty Seven Lakh Fifty Thousand Only).on anticipation of getting Administrative Sanction for the purchase.

The matter was placed before the Full Time Directors as per note read as 4<sup>th</sup> above. Having examined the matter in detail, the Full Time Directors meeting held on 27/06/2022,

Resolved to accord Administrative Sanction for the procurement of 13300 Nos. of 410 SP-11-8M long swaged type galvanized steel Tubular Poles at a total PAC of Rs.23,27,50,000-/ (Rupees Twenty three Crore Twenty Seven Lakh Fifty Thousand Only).

Further resolved to ratify the action taken by the Chief Engineer (SCM) in floating colline tenders for 13300 Nos. of 410 SP-11-8M long swaged type galvanized steel Tubular Poles at a total PAC of Rs.23,27,50,000-/ (Rupees Twenty three Crore Twenty Seven Lakh Fifty Thousand Only).

Orders are issued accordingly.
