KSEBL is in requirement of various specialized officers who have 20 to 30 years of experience in specialized functions such as Project Investigation, especially complex hydro-electric, pumped back storage, transmission substations, protection and control works, emergency management etc. which cannot be immediately sourced from serving officers, in various critical project and investigation contexts, the Board has to resolve to recall their services on temporary contractual basis from willing officers. There is need to systemize these one-off arrangements in view of the large number of retirements amongst the senior officers whose expertise will be lost at once in 2022-2026.
