ABSTRACT

Basic developmental works in the play ground in possession of KSEBL at Chithirapuram - under Generation Circle Meencut - by using Panchayath fund - Permissive sanction accorded - Orders issued.

ORDER

The Chief Engineer (Generation), Moolamattom as per letter read as 1st above has forwarded the request of the President ,Pallivasal Grama Panchayath seeking permissive sanction for the basic developmental activities of the Play ground owned by KSEBL at Chithirapuram ,by using Government fund allotted to the Grama Panchayath.

It is reported that the above proposal has been originated as per the decision No. 14(5) of the meeting held on 25.11.2021, in connection with the Government project named as "ഒരു പഞ്ചായത്തിൽ ഒരു കളിസ്ഥലം " which was proposed to be implemented by using Panchayath development Fund allotted for the purpose.

The play ground is being used by KSEBL employees and their family members (around 200 odd people) residing in the KSEBL Colony at Chithirapuram and the General public in the locality. It is also used for conducting sports events of the nearby schools in the locality.

As per the revenue records the said play ground is in Pallivasal Village, Block No.14, re-survey No. 216 which was specifically entered as "Govt.- KSEB" in the Basic Tax Register. Also reported that the application for mutation of land in favour of KSEBL has been submitted and is in process at Village authorities.

In the above circumstances, it was recommended to give permissive sanction to the Pallivasal Grama Panchayath, for carrying out the basic developmental works in the play ground at Chithirapuram keeping the ownership with KSEBL, by using Government Fund conditionally based on an agreement executed between KSEBL and the Pallivasal Grama Panchayath.

The matter was placed before Full Time Directors as per note read as 2nd above. Having considered the matter in detail the Full Time Directors meeting held on 27.06.2022 resolved

developmental works in the play ground in possession of KSEBL at Chithirapuram, by using Government Fund, conditionally based on an agreement executed between KSEBL and the Pallivasal Grama Panchayath, keeping the ownership under KSEBL.

Further resolved to authorize the Deputy Chief Engineer, Generation Circle, Meencut to enter in to an agreement with the Pallivasal Grama Panchayath before commencement of the works.

Orders are issued accordingly.
