### ORDER

The Government of Kerala as per G.O read as 1<sup>st</sup> above, had deferred the periodical Surrender of Earned Leave for the financial year 2022-23 till 30<sup>th</sup> June 2022 in view of the economy measures adopted to tide over the financial constraints caused by the outbreak of Covid-19 pandemic. The order has been made applicable to the employees of various Universities in Kerala, Grant in Aid Institutions, Autonomous Bodies, Statutory Undertakings, Welfare Boards, Apex Societies and Public Sector Undertakings. The Last Grade Servants (including office attendants) and Part Time Contingent employees were exempted from the operation of this order. The Government in this order has also clarified that Terminal surrender of Earned Leave will not be affected.

As per the BO read as 2<sup>nd</sup> above,it was decided to defer the payment of Surrender of Earned Leave of the employees of KSEBL except the lowest grade employees till 30<sup>th</sup> June 2022 in line with the Government Order dated 30.03.2022. It was also decided that the payment of terminal surrender of earned leave shall be continued as at present.

The Government of Kerala as per G.O read as 4<sup>th</sup> above has decided to extend the applicability of the Government Order read as 1<sup>st</sup> above till 30.09.2022 to tide over the financial constraints.

The matter was placed before the Full Time Directors as per note read as 5<sup>th</sup> above.

Having considered the matter in detail, the Full Time Directors in its meeting held on 27.06.2022 has resolved to adopt the Government Order G.O(P) No.64/2022/Fin dated: 13.06.2022 for implementation in Kerala State Electricity Board Limited.

Orders are issued accordingly.


