ORDER

The Purchase Order read as 1st above was placed with M/s.GE T&D India Limited, Chennai on 28/06/2021 for the supply of 12 Sets. of 220kV & 104 sets of 110kV SF6 Circuit Breakers. The firm supplied 12 Nos. of 220kV SF6 Circuit Breakers within the contractual delivery schedule itself. But there was a delay in supplying 110kV SF6 Circuit Breakers and the supply details are as detailed in the table shown below.

M/s.GE T&D India Limited, Chennai as per letters read as 4th & 5th above have requested to apply Force Majeure Condition (FMC) based on COVID-19 pandemic for the Purchase Order and to extend the delivery schedule.

It is notified by the Ministry of Finance, Government of India vide Office Memorandum read as 2nd and 3rd above that COVID-19 situation should be considered as a case of natural calamity and FMC may be invoked, wherever considered appropriate

The Chief Engineer (SCM) has pointed out as per note read as 7th above that the delay in supply of the 110kV SF6 Circuit Breakers by M/s.GE T&D India Limited, Chennai was due to the lockdown imposed by the Government of Tamil Nadu, due to the upsurge in Covid-19 pandemic. Hence, it is recommended to extend the delivery period for the supply of 104 sets of 110kV SF6 Circuit Breakers, against Purchase Order No.SCM.36/2021-22 dated 28/06/2021 placed with M/s.GE T&D India Limited, Chennai as detailed below, without imposing penalty, considering the request of the supplier, based on Force Majeure conditions, on account of COVID – 19 Pandemic.
