ORDER

The Olikkal Small Hydro Electric Project (installed capacity of 5 MW and expected annual energy generation of 10.26 Mu) and the Poovaramthode Small Hydro Electric Project (installed capacity of 3 MW and expected annual energy generation of 5.88 Mu) are two cascading runoff river schemes proposed by the KSEBL in the Chaliyar basin in Kozhikode District.

The Government of Kerala accorded administrative sanction for implementing the Olikkal SHEP vide G.O. (MS) No.17/2012/PD Dated 28.07.2012 and the Poovaramthode SHEP vide G.O. (Rt) No.113/2014/PD Dated 30.04.2014.

KSEBL as per the B.O. read as 1st above had accorded revised administrative sanction for the implementation of Olikkal & Poovaramthodu SHE Projects as a single package for an amount of ₹107.643 Crore, including IDC and also to invite tender for executing the Civil and electro mechanical works of both the projects with indigenous machinery, as single package.

Later, as per the B.O. read as 3rd above, KSEBL accorded sanction for separate tendering for the civil works and to invite tender the Civil works of both Olikkal & Poovaramthodu SHEPs at 2018 DSR.

The e-tender for the execution of civil works of Olikkal & Poovaramthodu SHEPs was invited on 15.01.2022 with a PAC of ₹4404.00 Lakh on percentage rate system. The Evaluation Committee, in its meeting held on 05.04.2022 decided to qualify the 3 bidders participated in the tender and their price bids were opened on 08.04.2022.

As per price bid evaluation, M/s.PGCCPL-ARYACON Consortium, Aiswarya Towers, Karimugal (PO), Kochi, Ernakulam District has quoted the lowest amount of ₹50,24,65,140/- (Rupees Fifty Crore Twenty Four Lakh Sixty Five Thousand One Hundred and Forty only), including GST, which is 3.30% below the estimate.

The tender quotes have been reviewed by the Financial Adviser. The time of completion of the work is 36 months and the Defects Liability Period is 5 years

The Chief Engineer (Civil - Construction) North, has recommended to award the work, "Execution of civil works of Olikkal (5MW) & Poovaramthodu (3MW) Small Hydro Electric Projects" to the lowest bidder M/s PGCCPL-ARYACON Consortium, at their quoted amount of ₹50,24,65,140/- (Rupees Fifty Crore Twenty Four Lakh Sixty Five Thousand One Hundred and Forty only) including GST (DSR 2018 Price level), which is 3.30% below the estimate rate.

The Full Time Directors in its meeting held on 26.04.2022 considered the proposal and decided to place the matter before the Board of Directors for decision. Accordingly, the proposal was placed before the 64th meeting of the Board of Directors as per the Note read as 8th above.

Having considered the matter in detail the Board of Directors in its 64th meeting held on 12.05.2022 resolved to accord sanction to award the work on the Execution of the civil works of Olikkal (5MW) & Poovaramthodu (3MW) Small Hydro Electric Projects to M/s PGCCPL-ARYACON Consortium, Aiswarya Towers, Karimugal (PO), Kochi, Ernakulam District, for an amount of ₹50,24,65,140/- (Rupees Fifty Crore Twenty Four Lakh Sixty Five Thousand One Hundred and Forty only) including GST (DSR 2018 Rates) at 3.30% below estimate rate.

The Chief Engineer (Civil - Construction) North shall take further necessary action in this regard.


