Subsequently, Sri.Arjun K S, member of the KSEB Volleyball (Men) team who was selected as a reserve player was also granted permission to participate in the Prime Volleyball League subject to terms and conditions mentioned in the B.O read as 1<sup>st</sup> above.

As per the prevailing directions in the B.O read as 1<sup>st</sup> above, the Full Time Directors may grant permission to sports persons to play for other teams in exceptional cases subject to the following conditions.

Prior permission of the Board shall be obtained for playing for other teams by submitting application for LWA with all necessary particulars.

- Duty leave or any other kind of leave other than LWA shall not be granted to any sports persons for playing for other teams
- The private clubs or private institutions inside the State as well as all clubs and institutions outside the State which propose to avail the services of the sports person shall pay the Board an amount equal to half of the remuneration paid to the player for availing services of players recruited in KSEBL.
- The private clubs or private institutions inside the State as well as all clubs and institutions outside the State which propose to avail the services of the sports person shall pay the Board an amount equal to half of the remuneration paid to the player for availing services of players recruited in KSEBL
- The Club or institution which proposes to avail the services of the sports person appointed under sports quota in KSEBL shall also apply to KSEBL with terms and conditions in respect of the contract with teams.

The members of the KSEB Volleyball (Men) team who had participated in the Prime Volleyball League as per submission read as 2<sup>nd</sup> above have requested to give relaxation in the above terms and conditions since their service benefits are adversely affected while participating in the Championships representing other Clubs/teams. The matter was placed before the Director Board as per note read as 4<sup>th</sup> above

Having considered the matter in detail, the Board of Directors in its 64<sup>th</sup> Meeting held on 12-05-2022 resolved,

1 To revise the existing guidelines for granting permission by the Full Time Directors to persons recruited under sports quota to play for other clubs/teams may be revised classifying the championships/tournaments as follows.

## Professional League Championships

- Prior permission of the Board shall be obtained for playing for other teams by submitting all necessary particulars.
- Eligible leave shall be granted for the period of coaching camp and LWA shall be granted during the period of participation in the championship/tournament.
- The club or institution which proposes to avail the services of the sports person appointed under sports quota in KSEBL shall also apply to KSEBL with terms and conditions in respect of the contract with teams.
- The club/institution availing the services of persons recruited under sports quota should promote the name of KSEBL in the championship/tournament.
- There should not be any official obligatory Championships for KSEBL during that period

### Invitation/Friendly or any other tournaments

Prior permission of the Board shall be obtained for playing for other teams by submitting application for LWA with all necessary particulars.

- Duty leave or any other kind of leave other than LWA shall not be granted to any sports  $\Pi$ ) persons for playing for other teams
- The private clubs or private institutions inside the State as well as all clubs and iii) institutions outside the State which propose to avail the services of the sports person shall pay the Board an amount equal to half of the remuneration paid to the player for availing services of players recruited in KSEBL.
- The club or institution which proposes to avail the services of the sports person  $(\nabla)$ appointed under sports quota in KSEBL shall also apply to KSEBL with terms and conditions in respect of the contract with teams.
- There should not be any official obligatory championship/tournament for KSEBL during V) that period
- 2) To make applicable the revised terms and conditions for participation in Professional League Championships to the following members of the KSEB Volleyball (Men) team who have been already granted permission to participate in the Prime Volleyball League from 5th to 27th February 2022.
