ORDER

M/s. Ambili Theatre (LCN.7/4792) was a non-live HT consumer which comes under Electrical Circle, Kannur. The HT service connection in respect of the consumer was disconnected on 26/02/2019 and physically dismantled on 11/11/2019 due to default of current charges. The consumer has an outstanding arrear amounting to Rs 13,40,993/- as on 10/05/2022 (including interest) towards current charges from the consumption month of 2/2018 to 9/2019.

Now the consumer as per letter read as 2^{nd} above has requested for OTS Scheme sanctioned by KSEBL as per the order read as 1^{st} above. Accordingly, the matter was placed before the Full Time Directors, KSEBL as per the note read as 3^{rd} above.

Having considered the matter in detail, the Full Time Directors in its meeting held on 17/05/2022 resolved to permit the consumer M/s. Ambili Theatre to clear the arrears under OTS Scheme 2022.

The consumer is having an outstanding arrear amount of Rs.990047/-(Principal-900540 & Interest-89507) as on 10/05/2022 at OTS rate with a per day interest of Rs.164/- upto 20/05/20.
