ORDER

Smt. Rema Devy. S had joined KSEB Service on 08.03.2001. Prior to that she had rendered service in Agricultural Department from 11.05.1998 FN to 29.11.2000 AN and in Municipal Common Service from 30.11.2000 to 07.03.2001. Her prior service in Agricultural Department can be reckoned for pensionary benefits in Kerala State Electricity Board Limited as per the existing rules. But the Municipal Common Service is not reckonable for pensionary benefits in Kerala State Electricity Board Limited. Smt. Rema Devy has submitted a representation read 3rd above and requested to reckon her prior service in both the departments in the light of the Government Order dated 21.06.2008.

A legal opinion from the Legal Adviser and Disciplinary Enquiry Officer as per note read as 4th above has been obtained as per the prevailing rules in Kerala State Electricity Board Limited in the light of Orders read as 1st and 4th above the request cannot be declined.

After examining the matter in detail, in view of the opinion rendered by Legal Adviser and Disciplinary Enquiry Officer, the Chairman and Managing Director has directed to place the matter before the Full Time Directors. Accordingly, the matter was placed before the Full Time Directors as per note read as 5th above. Having considered the matter in detail, the Full Time Directors in its meeting held on 12.05.2022 resolved to accord sanction to consider the request of Smt. Rema Devy. S, Sub Engineer (Civil), Office of the Chief Engineer (Civil Construction) South for reckoning her prior service in Municipal Common Service from 30.11.2000 to 07.03.2001 for pensionary benefits in Kerala State Electricity Board Limited as per legal opinion rendered by the Legal Adviser and Disciplinary Enquiry Officer.

Orders are issued accordingly.
