The Chief Engineer (Generation) as per letter read above has reported that the vehicles of Electrical Maintenance Division, Moolamattom & Generation Division ,Moolamattom have been replaced with Electric vehicles and requested for allocation of the following spared vehicles to Generation Division, Thrissur & Equipment Monitoring Sub Division, Moolamattom.

In this connection, it is also reported that the newly formed Generation Division ,Thrissur has started functioning on February 2021 and vehicle for the use of the Executive Engineer was arranged on contract basis. But, due to the frequent hike in fuel pricing ,escalated cost of maintenance etc. the contractors discontinued the vehicle supply after two to three months of executing the agreement and at present no vehicle is available for the use of the Executive Engineer.

Regarding the EMSD, Moolamattom, even though a 17 seater Traveller type vehicle is available for the use of the the Sub Division, the Asst.Executive Engineer has requested a separate vehicle for his visit to various ongoing projects being a technical committee member for those projects, without disturbing the routine activities of the Sub Division. Therefore, it was recommended that the spared vehicles available at Electrical maintenance Division, Moolamattom & Generation Division,Moolamattom may be allotted to Generation Division,Thrissur & Equipment Monitoring Sub Division, Moolamattom

The matter was placed before the Full Time Directors as per note read as 2<sup>nd</sup> above.

Having considered the matter in detail, the Full Time Directors meeting held on 12-05-2022 resolved to accord sanction for allocation of the spared vehicles available at Electrical Maintenance Division, Moolamattom & Generation Division, Moolamattom to Generation Division, Thrissur & Equipment Monitoring Sub Division, Moolamattom .
