ORDER

The Writ Petition No.78/2022 filed by Sri.M.B.Mohanachandran Nair, Assistant Engineer (Retired) praying to set aside Ext.P9, P10, P11, P12 and 14 orders, insisting to execute Indemnity Bond for the disbursement of pensionary benefits, has been disposed vide judgment read 1st.
