ORDER

Sri.M.M.Mathew Roy retired as Technical Member from KSEBL on 31.05.1996. Government as per Order read as 1st above sanctioned Provisional Pension upto 75% of the admitted value withholding DCRG due to pending various Vigilance Cases against the incumbent. Kerala State Electricity Board Limited issued order read 2 above in this respect. Sri.M.M.Mathew Roy expired on 10.11.2008. The Family Pension was sanctioned to Smt.Shanta Roy, W/o Late M.M.Mathew Roy as per B.O read as 3d above. Smt.Shanta Roy expired on 28.02.2020. Now Smt.Preetha Sekhar D/o Late.M.M.Mathew Roy has submitted a representation for the release of the withheld pensionary benefits in respect of Late M.M.Mathew Roy.

The Chief Vigilance Officer has forwarded the Government letter read as 4th above wherein it is informed that the Government has no objection in giving pensionary benefits to the legal heirs of the Late M.M.Mathew Roy, Technical Member (Rtd). The Legal Advisor & Disciplinary Enquiry Officer as per the Note read as 5th above opined that the Government has no objection in disbursing the withheld pensionary benefits and there does not appear any Writ Petition or other Court Proceedings against the non-disbursal of the pending pensionary benefits. In this circumstances, the pending withheld pensionary benefits to Late M.M.Mathew Roy, Technical Member (Rtd) may be sanctioned subject to the orders/decision of the Board.

The Chief Engineer (HRM) as per the Note read as 6th above has forwarded the financial commitment in releasing the withheld pensionary benefits in respect of the Late M.M.Mathew Roy along with Financial liability as follows.
