### ABSTRACT

E tender for the execution of PMU works under Electrical Section Chirayinkizhu - Single tender sanction - Orders issued.

### ORDER

E tender was invited for carrying out the PMU work of 11kV OH line construction from Chebinmoola AB to Azhoor Village AB with a PAC of ₹6,01,948/- under Electrical Section Chirayinkizhu. Though 3 bidders participated in the bid, only one bidder was eligible and hence the work was re-tendered. 6 bidders participated in the re-tender but on bid evaluation only one participant turned eligible. The re-tender was cancelled as the tender notice issued for publication in dailies was not seen published and as there was only one eligible participant.

Re-tendering was again arranged and only one participant Sri.Anoop U M, Aradhana, Avanavancherry has participated. The quoted rate is ₹5,05,696.56 which is 15.99% below the estimate rate.

The Chief Engineer, Distribution (South) as per letter read as 1<sup>st</sup> above has sought sanction for placing work order with the single bidder and the matter is placed before the Full Time Directors for a decision as per note read as 2<sup>nd</sup> above.

Having considered the matter in detail, the Full Time Directors in the meeting held on 21.04.2022, resolved to accord sanction to the Chief Engineer (Distribution South), for accepting single tender for the execution of the PMU work of 11kV OH line construction from Chebinmoola AB to Azhoor Village AB under Electrical Section Chirayinkizhu and for awarding the said work at 15.99% below the estimate rate as quoted by the single bidder, Sri. Anoop U.M, Aradhana. Avanavancherry as only single bid was received on re-tendering twice.

Orders are issued accordingly.
