## ORDER

The (2x37.5 MW) Idamalyar Power Station commissioned during 1987 is situated in an isolated and remote forest area. Around 50 employees and contract persons are working in the power station and around 10 employees are also working there under the Research & Dam Safety Division, Idamalayar. The nearest hospital facility available is at Kothamangalam which is around 25 Km away from the station.

Under the above circumstances, the exigency of a medical evacuation facility at the station as pointed out by the employees has been considered positively by KSEBL and sanction was accorded for the procurement of an Ambulance for the use at Idamalayar Power Station, as per B.O read as 1<sup>st</sup> above.

Accordingly, an estimate amounting to ₹17,50,000/-(Rupees Seventeen lakh Fifty Thousand only) has been prepared based on the offer collected from M/s Force motors Limited, for the procurement of a new Force Traveler T1 Ambulance BSVIFM2.6CR 3350(10+P) through GeM portal and requested sanction for the same. The GeM Portal price includes GST @28% and TCS @1%. Provision has been given in the estimate, for Permanent Registration, Insurance & Road Tax etc. The matter was placed before the Full Time Directors as per note read as 3<sup>rd</sup> above.

Having considered the matter in detail, the Full Time Directors meeting held on 21.04.2022 resolved to accord sanction to the Chief Engineer(Generation), Moolamattom for the procurement of a new Force Traveler T1 Ambulance BSVIFM2.6CR 3350(10+P) vehicle through GeM portal, at an all inclusive estimated cost of ₹17,50,000/- (Rupees Seventeen Lakh Fifty Thousand only), for the use at Idamalayar power House.

Orders are issued accordingly.
