ORDER

As per the letter read as 1st above, the Chief Engineer (Distribution Central), Ernakulam has reported that the Electrical Section, Kombodinjamakkal and Electrical Sub Division, Vellangallur under Electrical Circle, Irinjalakuda are functioning in rented buildings at a total monthly rent of ₹37,725/-. 50.58 cents of land in Kottenallur Village, Mukundapuram Taluk, Thrissur District was purchased for the construction of 33 kV Substation, Thumboor and Electrical Section, Kombodinjamakkal. Out of the 50.58 cents, 15 cents of land has been earmarked for the construction of building for Electrical Section, Kombodinjamakkal. It is proposed for constructing a two storeyed building having a total plinth area of 215 m² [Ground floor 140 m² & first floor 75 m²] for accommodating Electrical Section, Kombodinjamakkal and Electrical Sub Division, Vellangallur in the land available at the 33 kV Substation compound, Thumboor. The approximate cost of construction of the proposal comes to ₹96,00,000/-.

The matter was placed before the Full Time Directors as per the note read as 2nd above.

Having considered the matter in detail, the Full Time Directors in the meeting held on 01/10/2021, resolved to accord sanction for constructing a double storeyed building for accommodating Electrical Section, Kombodinjamakkal and Electrical Sub Division, Vellangallur in the 15 cents of land available at the 33 kV Substation compound, Thumboor and to approve the plan for the construction of the building having a total plinth area of 215 m² [Ground floor – 140 m² & first floor – 75 m²] by limiting the total cost of construction to ₹96,00,000/-.

Orders are issued accordingly.
