### ORDER

The Assistant Engineer, PWD Road Section, Kannur has requested to shift HT/LT poles, 11kV OH line, 11kV ABC, KFON cables, LT OH line in connection with the "Perlassery Town Beautification"work. The Secretary Perlassery Grama Panchayath has requested for carrying out the work on MOU basis.

An estimate amounting to Rs 5,64,845/- is required for shifting the electrical utilities. The Deputy Chief Engineer, Electrical Circle, Kannur reported vide letter under reference (4) that the Executive Engineer, PWD Road Section, Kannur has submitted an undertaking that an estimate amount of Rs 5,64,845/- will be remitted after getting their fund and also requested necessary sanction for shifting the HT/LT poles for the development of Perlassery town beautification under the Legislative Assembly area of Hon'ble Chief Minister.

The matter was placed before the Full Time Directors as per note read as 3<sup>rd</sup> above.

Having examined the matter in detail, the Full Time Directors in the meeting held on 01.10.2021 resolved to accord sanction to the Deputy Chief Engineer, Electrical Circle, Kannur for carrying out the shifting of the utilities in connection with the "Perlassery Town Beautification" work at an estimated amount of Rs 5,64,845/-(work deposit amount) based on an undertaking by the Executive Engineer, PWD Road Section, Kannur that the amount will be remitted at the earliest.

Orders are issued accordingly.
