### ORDER

Kerala State Electricity Board Ltd. is presently maintaining sports teams in Volleyball (Men & Women), Basketball (Men & Women), Football (Men), Tennis (Men) and Badminton-Shuttle (Men) disciplines.

As per the guidelines for recruitment under sports quota in KSEBL, the eligibility criteria for achievements of candidates in the respective disciplines is as follows.

- a. candidates should have either represented the Country in International competitions during the year of notification or immediately preceding two years; or
- b. should have represented the State in Youth / Junior / Senior category in National championships during the year of notification or immediately preceding two years; or
- c. should have represented the State in National Games during the year of notification or immediately preceding two years; or
- d. should have represented University in the Inter Zone Championship conducted under the auspices of the Association of Indian Universities during the year of notification or immediately preceding two years; or
- e. should have attended the coaching camp of the National team during the year of notification or the immediately preceding year in respective discipline.

The Chairman & Managing Director as per note read above reported that many candidates may not be eligible to apply for the sports quota recruitment as per the above eligibility criteria since National/Inter University Championships were not conducted during the year 2020 and 2021 due to the Covid-19 pandemic. It was also suggested to modify the period of achievements as achievements during the year of notification or immediately preceding three years for the sports recruitment for the year 2021-2022.

Having considered the matter in detail, the Director Board in its meeting held on 28-09-2021 resolved to modify the eligibility criteria for the period of achievements of candidates in the respective disciplines as detailed below for the sports recruitment for the year 2021- 2022.

**i) Sports quota recruitment for the year 2021**

- a. candidates should have either represented the Country in International competitions during the year 2018 to 2021 ; or
- b. should have represented the State in Youth / Junior / Senior category in National championships during the year 2018 to 2021; or
- c. should have represented the State in National Games during the year 2018 to 2021; or
- d. should have represented University in the Inter Zone Championship conducted under the auspices of the Association of Indian Universities during the year 2018 to 2021; or
- e. should have attended the coaching camp of the National team during the year 2018 to 2021 in respective discipline.

**ii) Sports quota recruitment for the year 2022**

- a. candidates should have either represented the Country in International competitions during the year 2019 to 2022; or
- b. should have represented the State in Youth / Junior / Senior category in National championships during the year 2019 to 2022; or
- c. should have represented the State in National Games during the year 2019 to 2022; or
- d. should have represented University in the Inter Zone Championship conducted under the auspices of the Association of Indian Universities during the year 2019 to 2022; or
- e. should have attended the coaching camp of the National team during the year 2019 to 2022 in respective discipline.
