ORDER

M/s. RLV College of Music and Fine Arts, Thripunithura, is an existing HT consumer (LCN 12/6944) with a contract demand of 78kVA and connected load of 128.9kW +15HP under Electrical Section, Thripunithura. The Deputy Chief Engineer, Electrical Circle, Ernakulam, as per the letter read as 1st above, has reported that the consumer has requested for reducing their contract demand from 78kVA to 50kVA without change in connected load.

The Special Officer(Revenue) has intimated that, an amount of Rs.3,28,968/- towards current charge arrears is pending for realization from the subject consumer, as on 28.05.2021.

The Deputy Chief Engineer, Electrical Circle, Ernakulam, has requested the consumer to clear the arrears and to remit the supervision charges in order to proceed further. In reply, the Principal intimated that they have remitted the supervision charges and being a Government institution they need allotment from Government to remit the arrears and have requested to reduce the contract demand without remitting the arrears.

The matter was placed before the Full Time Directors as per the note read as 2nd above.

Having considered the matter in detail, the Full Time Directors in the meeting held on 17.09.2021 resolved to accord sanction to the Deputy Chief Engineer, Electrical Circle, Ernakulam to proceed with the reduction in contract demand of M/s. RLV College of Music and Fine Arts, Tripunithura, after obtaining an undertaking to remit the pending arrears at the earliest.

Orders are issued accordingly.
