## **Abstract**

Construction of building for accommodating Electrical Section, Koppam under Electrical Circle, Shoranur – Approval of plan and Administrative Sanction – Accorded – Orders issued

## **ORDER**

As per the letters read as 1<sup>st</sup> above, the Chief Engineer (Distribution North), Kozhikode reported that the Electrical Section, Koppam under Electrical Circle, Shoranur is presently functioning in a rented building at a monthly rent of ₹18,000/- located at Koppam Town. This rented building is not suitable for functioning as a Section office as it is congested with inadequate space for storing materials and parking vehicles. It is reported that sufficient land is available at 110 kV Substation compound, Koppam for constructing a new building for Electrical Section, Koppam. The Chief Engineer (Transmission North) had recommended to consider sanction for handing over the land at 110 kV Substation, Koppam to the Distribution wing.

It is proposed to construct a single storied building having a plinth area of 172.62 m<sup>2</sup> for Electrical Section, Koppam in the land available at 110 kV Substation, Koppam. The estimated amount of construction is ₹50 lakh.

In the above circumstances, the Chief Engineer (Distribution North), Kozhikode has requested Administrative sanction for an amount of ₹50 lakh for constructing a single storied building having a plinth area of 172.62 m<sup>2</sup> for accommodating Electrical Section, Koppam in the land available at 110 kV Substation, Koppam.

The matter was placed before the Full Time Directors as per the note read as 2<sup>nd</sup> above.

Having considered the matter in detail, the Full Time Directors in the meeting held on 17/09/2021, resolved to accord sanction for constructing a single storeyed building for accommodating the Electrical Section, Koppam in the land available at 110 kV Substation, Koppam and to approve the plan for the construction of the building having a total plinth area of 172.62 m<sup>2</sup> by limiting the total cost of construction to ₹50,00,000/-

Orders are issued accordingly.
