ORDER

The Board in its 56th meeting held on 01-01-2021 vide Proceedings in Agenda No. 08-12/2020 and B.O (DB) No. 10/2021 dated 11-01-2021 had accorded sanction to award the work of Erection of Supplied Electro Hydro Mechanical Equipment and Supply and Erection of BOP Equipment of Pallivasal Extension Scheme Hydroelectric Project (2x30MW) to M/s. TVPPL-KSK-REHPL-DEC Consortium at an amount of Rs. 66.74 Crore inclusive of taxes. As per the Board Order read as 1st above, the tender and Work Order for the same was cancelled and the same was retendered as per the tender read as 2nd above, with modified tender conditions. Subsequently, as per B.O read as 3rd above sanction was accorded to further modify the Clause No. 2.29.1 for pre-qualification to ensure more competition. Both the above Board Orders were issued in anticipation of approval from the Board of Directors. Accordingly the matter was placed before the Board of Directors as per Note read as 4th above.

The Board was informed about the decision of Full Time Directors to cancel the Work Order issued to the Contractor due to non furnishing of Embassy attested documents and DPIIT registration details and to retender the work with modified tender conditions on reverse bidding basis taking Rs. 61,58,22,393/- (PAC amount excluding GST) as the cap. It was also reported about the decision of Full Time Directors to exempt the pre-qualified bidders from forfeiting their bid security on cancellation of Tender.

Having considered the matter in detail, the Board of Directors in its meeting held on 28-09-2021 resolved to ratify the action taken by the Full Time Directors for the following.

1. To allow the Chief Engineer (Generation & PED) to cancel the W.O. issued to M/s. TVPPL-KSK-REHPL-DEC Consortium.
2. To allow the Chief Engineer (Generation & PED) to retender with reverse bidding basis taking Rs.61,58,22,393/- (PAC amount excluding GST) as the cap and reverse auction.

3. To modify tender condition for pre-qualification as detailed in B.O (FTD) No. 568/2021 (No. 25/AE2/2014/CE(PED)) dated 09-08-2021 and subsequent modification vide B.O (FTD) No. 652/2021 (25/AE2/2014/CE(PED)) dated 14-09- 2021.
4. To exempt the pre-qualified bidders M/s. SSIPL - Allonward Consortium and M/s. TVPPL-KSK-REHPL-DEC Consortium from forfeiting their bid security on cancellation of Tender.

Orders are issued accordingly.
