**ORDER**

KSEBL, as per the BO read as 1<sup>st</sup> above, approved charging fee in respect of the EV Charging Stations already established by KSEBL as Rs.13/unit + applicable GST charges of 18% and the total cost per unit arrives to Rs.15.34/-. It was also sanctioned to entrust the Chief Engineer (IT, CR & CAPS) for executing a Commercial Agreement with the contractor and an account in the name of Chief Engineer (IT, CR & CAPS) was opened to collect the revenue exclusively from the EV Charging Stations.

As per the LoA read as 2<sup>nd</sup> above, the Setting up of EV Charging points at KSEBL's Distribution Poles in 10 locations of Kozhikode city as a Pilot Project is awarded to M/s. ChargeMOD, BPM Power Pvt Ltd and the project is expected to be inaugurated on 9.10.2021 by the Honorable Minister of Electricity, Government of Kerala. The contractor has requested to provide the bank account details of KSEBL for revenue transfer.

Considering the present situation, it is advisable to continue the present status of using the bank account opened in the name of CE (IT, CR & CAPS) to collect the revenue, exclusively from the EV Charging Stations and execute a commercial agreement between CE (IT, CR & CAPS) & the contractor M/s.ChargeMOD, BPM Power Pvt Ltd, as in the previous case.

Similarly, as reported by M/s. ChargeMOD, BPM Power Pvt Ltd as per email read as 3rd above that they are only having a dedicated prepaid method to allow customers to access the charging station and requesting for the invoicing nature and amount for preparation of the billing of the pole mounted EV Charging Stations.

Since the investment cost of Pole mounted EV Charging Stations (Rs.25200/- per station including GST) are less compared to the DC Fast Charging Stations ,it is advisable to consider the charging rate of Rs. 9+ applicable GST for the pole mounted EV Charging Stations only for 3 wheelers and 2 wheelers.

The above matter was brought to the attention of the Full Time Directors, KSEBL as per note read as (4).

Having considered the above matter in detail, the Full Time Directors in its meeting held on 1.10.2021,

1. Resolved to authorize the Chief Engineer (IT, CR & CAPS) for executing a Commercial Agreement with M/s chargeMOD, BPM Power Pvt Ltd for the Setting up of EV Charging points at KSEBL's Distribution Poles in 10 locations of Kozhikode city as a Pilot Project and the bank account in the name of Chief Engineer (IT, CR & CAPS) opened to collect the revenue exclusively from the EV Charging Stations be continued to receive the revenue from the 10 Pole mounted charging stations in Kozhikode city also.
2. Further resolved to implement pre paid billing system to the EV Charging Stations at KSEBL 's Distribution Poles in 10 locations of Kozhikode city as a Pilot Project and other forthcoming stations.
3. Further resolved that the charging fee for the pole mounted EV Charging stations is fixed as Rs. 9/unit + applicable GST and other taxes and duties.

Orders are issued accordingly.
