ORDER

The E&M works of Poringalkuthu SHEP (1 x 24 MW) are in the final stages and the project is scheduled to be completed by this financial year.

The Chief Engineer (Generation &PED) as per Note read as 4th above reported that the Protection scheme, Excitation scheme, Governor System and control panel designs etc of Poringalkuthu project were reviewed and carried out under the guidance of Sri. C.N Jayarajan, then Executive Engineer, Protection Monitoring Division, Moolamattom who had retired as Deputy Chief Engineer from KSEBL's Service on superannuation on 31/05/2021. It was reported that his expertise in the commissioning of the Generator will be very helpful during the commissioning activities and he had conveyed his willingness to extend his service voluntarily without any monetary benefit till the commissioning of the project.

It was reported that, considering the profound experience of Sri C.N Jayarajan in matters relating to the protection and automation, excitation and governing systems, the KSEBL had already accorded sanction as per the B.O read as 2nd above for retaining him in the Design review Committee for the Balance E & M works of Thottiyar (1x30 +1x10) MW HEP and Technical committee for the RMU works of Kuttiyadi (3x25MW) HEP as he had agreed to provide his service voluntarily without any cost to KSEBL. Considering the above, the Chief Engineer (Generation &PED) has requested sanction for availing the services of Sri C.N Jayarajan, Deputy Chief Engineer (Retired) on voluntary basis till the commissioning of the subject project.

The matter was placed before the Full Time Directors as per Note read as 4th above. Having considered the matter in detail, the Full Time Directors in the meeting held on 01-10-2021 resolved to accord sanction to avail the service of Sri C.N Jayarajan, Deputy Chief Engineer (Retired) on voluntary basis till the commissioning of Poringalkuthu 1x24 MW SHEP.
