ORDER

As per the Minutes of Meeting read as 2nd above, it has been decided to allocate 25 MW quantum to ANERT, of the total allocation of 200 MW received by KSEBL in the MNRE subsidy scheme for 2020-21. The projects shall be executed through the developers empaneled by KSEBL in the scheme. The consumers for 25 MW capacity will be identified and registered by ANERT.

During the meeting conducted with ANERT, and the developers within Kerala on 14.9.2021 it has been decided to amend certain tender conditions as per the Minutes of the meeting read as 3rd above.

The State Nodal Officer requested sanction for reallocation of subsidy quantum to ANERT and also proposed corrigendum to the tender conditions as per note read as 4th above.

Having considered the matter in detail, the Full Time Directors in its meeting held on 23.9.2021

Resolved to accord sanction to reallocate 25 MW quantum of the total quantum 200 MW allocated to KSEBL in the subsidy scheme 2020-21 by the Ministry of New and Renewable Energy to ANERT subject to the condition that the project shall be executed through developers as per the empanelment list published by KSEB Ltd.

Further resolved to accord sanction to issue corrigendum to the tender appending clause 2.6 as follows.

" 2.6 ALLOCATION OF CAPACITY IN PLANT CAPACITY RANGES ABOVE 3 kW CAPACITY

The successful bidders in this tender will be allocated quantum in plant capacity range above 3 kW based on their request and subject to the following conditions.

1. The consumers shall be identified and registered through the respective developers.
2. The developer shall have completed at least 50 % of the capacity allocated in 1,2 and 3 kW plant capacity ranges as per the letter of empanelment.
3. The eligible quantity (in plant capacity range above 3 kW) will be 50 % of the total plant capacity successfully commissioned in 1,2 and 3 kW plant capacity ranges.
4. The rates applicable would be the rates as per the existing empanelment list dated 12.7.2021 published by KSEBL based on Tender No.4/2020-21 dated 15.2.2021
5. The technical specification will also be as per the Tender No.4 /2020-21 wherein the Module efficiency shall be minimum 17 % , Module wattage shall be 330 W minimum and inverter capacity shall be atleast 80 % of the module capacity and modules shall be DCR compliant. Also benchmark rates applicable will be that of 2020-21.

Further resolved to accord sanction to issue corrigendum to the tender "In the event of non-participation of bidders whom can be classified as Category A, the price bids of three firms classified as category B offering maximum quantum and having maximum cumulative turnover during the last 5 years will be considered for financial bid opening."

Orders are issued accordingly.


