ORDER

The Deputy Chief Engineer, Electrical Circle, Palakkad. has forwarded a petition received from Sri. Sudeep B at the Sandhvana Sparsham Adalath conducted on 08/02/2021 along with the decision of the Adalath Committee .

Sri. Sudeep B and Parathi Agriculturists Committee, Kambalamkode, Naduvthuppara (under ES Peringottukurissy) have requested for shifting of 11kV posts which causes hindrance to the passage of agricultural machines which delayed harvest on time. The 11kV Post (PN119) located in the pathway has to be shifted to a suitable location so that road widening can be executed by the Panchayath.

The Adalath decision noted in the above case is that KSEB Palakkad shall visit the site urgently and the work may be carried out by reducing 50% of the estimate cost .

The work involves dismantling of 355 m HT lines 608 m LT lines and stringing of 385 m HT/LT lines. An estimate amounting to Rs 2,82,371/- is required for the execution of above work.

The matter was placed before the Full Time Directors as per note read as 2nd above.

Having examined the matter in detail, the Full Time Directors in the meeting held on 10.09.2021 resolved to accord sanction to the Deputy Chief Engineer, Electrical Circle, Palakkad for carrying out the work of shifting HT/LT line and poles to convenient place at Kamblamkode for road widening in favour of Sri. Sudeep B and Parathi Agriculturists Committee, Kambalamkode on remitting 50% of the cost of shifting by the petitioner (balance 50% to be met by KSEBL), considering that the petition was received in Sandhvana Sparsham Adalath 2021, not forming a precedence.

Orders are issued accordingly.


