ORDER

KSITIL & BEL as per letter read as 1st above reported that KSEBL has already laid/planned for 24F OPGW in the following links approved under package-B and hence KSITIL requested sanction for replacing the existing 24F OPGW with 48F OPGW, under KFON project. It is reported that BOQ for these stretches have been approved under KFON Project.

4	Thrissur	110kV Kalamassery - Malayattur	24F OPGW planned by KSEBL. Not laid.

The matter was discussed in the meeting held on 28.07.2021 between the CMD, KSEBL and the MD, KSITIL and it was assured by the CMD, KSEBL that necessary support would be given and approval will be issued wherever possible. The matter was also discussed in the meeting conducted with Field Engineers of Northern region on 31.08.2021.

KSITIL as per letter read as 4th above reported that the above links need urgent completion as the project completion is planned for 31.12.2021. The remarks on the above four links regarding replacing the portion of 24 Fibre OPGW already laid by KSEBL

with 48F under KFON project, was sought from the Chief Engineer (Trans.- System Operation), Chief Engineer (Transgrid) and Chief Engineer (Transmission- North) and the Chief Engineers submitted theirs remarks as per letters read as 5th, 6th and 7th above respectively. Based on the remarks received from these offices, as replacing 24F OPGW with 48F will be beneficial to KSEBL in long run and the fact that M/s. BEL will provide 7 years warranty for the replaced 48F OPGW under KFON project, the matter was placed before the Full Time Directors as per the Note read as 8th above.

Having considered the matter in detail, the Full Time Directors, in the meeting held on 17.09.2021, resolved to accord sanction for replacing the portion of 24 Fibre OPGW already laid / proposed to be laid by KSEBL in the following links with 48F OPGW under KFON project.

- a) 110kV Panoor LILO Quilandy
- b) 110kV Meppayyur LILO (Panoor-Quilandy LILO)
- c) 110 kV Malapuram Kizhisseri
- d) 110 kV Kalamassery Malayattur (Proposed to be laid by KSEBL)

Further resolved to instruct KSITIL/BEL to take utmost care while dismantling the existing 24F OPGW so that the dismantled OPGW can be utilised in other locations.
