ORDER

KSEBL has decided to set up three new pole casting yards in Trivandrum, Kollam and Idukki districts and to revive the nonfunctional departmental yards in Choolissery and Mangattuparamba. KSEBL as per Board order read as 1st had accorded administrative sanction for an amount of Rs 13.50 Crores for this and the work was entrusted with the Chief Engineer (Civil Construction) South. Also as per Board order read as 2nd above sanction was accorded to reintroduce the departmental supervision by Assistant Engineer (Civil)/ Sub Engineer (civil) for ensuring the quality of PSC poles in the existing private pole casting yard and the newly proposed departmental yards either by deploying/giving additional charges and to entrust the Director (Gen.Civil) and Director (Distribution, IT & HRM) for the posting of staff.

Subsequently the Executive Engineer, Civil Division, Thiruvananthapuram was entrusted with the execution of the setting up of pole casting yard at Pothencode, the Executive Engineer, Investigation Division, Kottarakkara with the pole casting yard at Kundara and the Project Manager, Ladrum & Marmala Small HEP, with the Pole casting yard at Moolamattom as per B.O read as 3rd above. The remaining are maintenance work of Choolissery and Mangattuparamba yard and these were suggested to be entrusted with nearby offices of civil wing under the Chief Engineer (CC) North. By entrusting the work of setting new yards as well as maintenance of existing yards as above, there would be dual control on these offices for technical and administrative matters. To tackle this situation

and for maintaining single control for each unit, the Chief Engineers recommended a pattern for entrusting the ARU, design required for the work at the yard and the tender for awarding of new/ renovation works at each yard as detailed below and requested sanction for the same.

- The yards allocated as per Board orders referred shall be under the control of respective Chief Engineer as detailed below.
 - i. Yards at Pothencode and Moolamattom Under Chief Engineer (Civil Construction) South with ARU at Vydyuthi Bhavanam, Thiruvananthapuram and Civil Circle, Pallom respectively.
 - ii. Yard at Kundara— Under Chief Engineer (Civil Investigation & Construction Central) with ARU at Vydyuthi Bhavanam, Thiruvananthapuram.
 - iii. Yard at Mangattuparamba and Choolissery be entrusted with Project Manager, Pazhassi Sagar SHEP & Executive Engineer, MF II Division, Kolathara, Kozhikode respectively under Chief Engineer (Civil Construction) North with ARU at the Office of the Chief Engineer (Civil Construction) North.
- 2. The designs required for the works at the yards under the control of Chief Engineer (Civil Construction) South and Chief Engineer (Civil Investigation & Construction Central) shall be furnished from the design wing at Thiruvananthapuram under Chief Engineer (CC) South and for the works under Chief Engineer (Civil Construction) North, shall be furnished from Design and Consultancy, Kozhikode, as done for other construction works.
- Tenders for award of new/renovation works at each yard shall be floated and executed by the concerned Chief Engineer.

The above matter was placed before the Full Time Directors as per note read as 5th above. Having considered the matter in detail, the Full Time Directors in the meeting held on 10.09.2021, Resolved to accord sanction to entrust Administrative & Technical control of setting up of new pole casting yards and maintenance of existing departmental yards at an estimate of Rs. 13.5 crores sanctioned as per Board Order dated 5.11.2020 as follows:

1.Pothencode with Executive Engineer, Civil Division, Thiruvananthapuram (with ARU at Chief Engineer HRM) &, Moolamattom with Project Manager, Ladrum & Marmala SHEP (with ARU at Civil Circle, Pallom) under Chief Engineer (CC) South.

2.Kundara with Executive Engineer, Investigation Division, Kottarakkara (with ARU at Chief Engineer, HRM) under Chief Engineer (C-I&CC)

3. Mangattuparamba and Choolissery with Project Manager, Pazhassi Sagar SHEP & Executive Engineer, MF -II Division, Kolathara, Kozhikode respectively (with ARU at O/o Chief Engineer(CC) North) under Chief Engineer (Civil Construction) North.

Orders are issued accordingly.
