ORDER

KSEBL had accorded Administrative Sanction as per B.O read 1st above for inserting 5 nos. towers in 3 feeders and dismantling 5 nos. existing towers for increasing the clearance of the EHT line crossing to the proposed track of Phase II of the Metro alignment works under deposit work at an estimated cost of Rs. 12.032 Cr. including GST. Also it is reported that the work is envisaged to be executed with material supply and work both being carried out by KMRL under the supervision of KSEBL and the supervision charges amounting to Rs. 1,09,37,052 and all other statutory expenses for the work are to be borne by KMRL .

As per letter dated 02.07.21 , M/s. KMRL requested KSEBL to provide the details of Tower Drawings, Technical Particulars/ Specifications, foundation Drawings, design details for EHT towers ,Bill of Quantities, Model Tender documents of KSEB General Condition, Special Condition, technical specifications etc.

The Director(Transmission and System Operation) had intimated M/s. KMRL, vide letter dated 12.08.2021, that the following two options for executing the work and requested their willingness on the options .

a. To remit the full deposit amount to KSEBL so that KSEBL will carried out the work with supply of materials including tower in favour of M/s. KMRL .

or

b. The cost of design and development of towers for handing over the technical particulars has to be met from M/s. KMRL.

As per letter read 2nd above , the Director Systems, KMRL had furnished their willingness to accept the Option 1 , ie. to remit the full deposit amount to KSEBL and the work would be undertaken by KSEBL .

In order to execute the entire work by KSEBL as per the request from M/s KMRL, the Director(T&SO) has recommended to amend the B O read 1 above to the extent that the work for inserting 5 nos. towers in 3 feeders and dismantling 5 nos. existing towers under Transmission Circle, Kalamassery, for increasing the clearance of the EHT line crossing the proposed track of Phase II of the Metro alignment, in favour of M/s KMRL for an amount of Rs. 12.032 Crore (Rupees Twelve Crore three lakh and twenty thousand) be undertaken by KSEBL on work deposit basis after collecting the applicable deposit amount from M/s KMRL.

The matter was placed before the Full Time Directors as per note read as 2rd above.

Having considered the matter in detail, the Full Time Directors in the meeting held on 10.09.2021,

Resolved to accord sanction to amend the B.O(FTD) No.113/2021/D(T&SO)/T3/Klsy/KMRL/2020-21 Dated 08.02.2021, to the extent that, an Administrative Sanction for the work for inserting 5 nos. towers in 3 feeders and dismantling 5 nos. existing towers under Transmission Circle, Kalamassery, for increasing the clearance of the EHT line crossing the proposed track of Phase II of the Metro alignment, in favour of M/s KMRL for an amount of Rs. 12.032 Crore (Rupees Twelve Crore three lakh and twenty thousand only) subject to condition that the entire work shall be undertaken by KSEBL on work deposit basis.

Orders are issued accordingly.
