ORDER

Smt.Grima Merlin Varghese, Junior Assistant & member of the KSEB Basketball (Women) team was injured while participating in the Common Wealth Games at Gold Coast, Australia in the year 2018. She underwent Autologous Chondrocyte Implantation (ACI) which involved a two stage surgery at Ortho One Hospital, Coimbatore and an amount of Rs.2,91,846/- (Rupees Two Lakh Ninety One Thousand Eight Hundred and Forty Six only) was incurred by her for the same.

Smt.Grima Merlin Varghese had earlier requested for full reimbursement of medical expenses incurred by her and as per the Office Order read above KSEBL had accorded sanction to settle the medical claim as per entitlement.

Now as per submission read as 4th above has again requested for full reimbursement of medical expenses stating that if the medical claim is settled as per entitlement she may not get even one third of the total expenditure incurred. The Sports Co-ordinator as per note read above has suggested to review the decision and to accord sanction for full reimbursement of medical expenses as a special case since the injury was occurred while representing the Country in Common Wealth Games and that the Deputy Secretary to Government of India & Member Secretary, NSDF had directed to approach the parent department to prefer the claim for reimbursement as per letter read above.

Having considered the matter in detail, the Full Time Directors meeting held on 10-09-2021 resolved to accord sanction for full reimbursement of medical expenses incurred by Smt.Grima Merlin Varghese, member of the KSEB Basketball (Women) team for undergoing two stage surgery at Ortho One Hospital, Coimbatore condoning the delay in submitting the claim as a special case by reviewing the Office order dated 19-05-2021.

Orders are issued accordingly.
