ABSTRACT

Cutting and removal of 4Nos of trees standing in the proposed site for the Transgrid down stream work at 110kV Substation premises, Kunnamkulam - Tender cum auction confirmation at 51.20% of assessed value – sanction accorded – Orders issued.

ORDER

As per the letter read as 1st above, the Chief Engineer, Transmission North has reported that 4Nos of trees that standing in the proposed area for the Transgrid down stream works at 110kV Substation compound Kunnamkulam. These trees are to be cut and removed so as to start the work immediately.

The valuation of the trees had been done by the Assistant Conservator of Forest, Social Forestry Division Thrissur and the survey report was prepared based on this valuation. This survey Report was sanctioned by the Deputy Chief Engineer, Transmission Circle, Thrissur with an assessed value of Rs.97,644/-.

Accordingly, the Deputy Chief Engineer, Transmission Circle, Thrissur had conducted tender cum auction 4 times after giving wide publicity. In the first time no tender forms were received and no bidders participated in the auction. In the 2nd & 3rd time no tender forms were received and only one bidder participated in the auction. In the fourth time no tender forms were received but three bidders participated in the auction. The highest amount is offered by Sri. C.V. Thomas, Chelappuzha House, Manalithara P.O and the same is Rs.50,000/- which is 51.20% of the assessed value.

It is further reported that, the chance of getting a higher offer seem to be remote due to the pandemic Covid -19 and poor participation of bidders in the tender cum auction. Moreover, cutting and removal of the trees are very urgent, since the Transgrid works are pending for want of site clearance

In view of the above the Chief Engineer, Transmission North has requested sanction for confirm the tender cum auction to the highest bidder Sri. C.V . Thomas, Chelappuzha House, Manalithara P.O at his offered amount of Rs. 50,000/- (Rupees Fifty thousand only)+GST+Forest Development charges+ other tax (if any) on timber which is 51.20% of the assessed value.

The matter was placed before the Full Time Directors as per the Note read as 2nd above. Having considered the matter in detail, the Full Time Directors in the meeting held on 10.09.2021.

Resolved to accord sanction to confirm the tender cum auction for the disposal of 4 Nos of trees standing in the proposed site for the Transgrid down stream work at 110kV Substation premises, Kunnamkulam to the highest bidder Sri. C.V.Thomas, Chelappuzha House, Manalithara P.O at his offered amount of Rs. 50,000/- (Rupees Fifty thousand only)+GST+Forest Development charges+ other tax (if any) on timber which is 51.20% of the assessed value.
