ORDER

The 54 MW (3x18) Sholayar power house was originally commissioned during 1966-68 and renovated during 2020. The R&M work was award to M/s Flovel Energy Private Ltd., as per the work order read 2nd above and the machines were put back in service after the R&M works on 05.10.2020, 20.01.2020 & 16.03.2019. The old and unserviceable taken back scrap of Generating units #1,#2,#3 (18 MW,11 kV, Rade Koncar Make /Type S3105-8 BSS) were verified by the Scrap Disposal Committee (SDC) members and sanction was accorded for the survey reporting of the above items by the Chairman, SDC, GPC, Moolamattom, as per proceedings read as 3rd & 4th above. The scrap value of Unit #3 machine at Sholayar Power House comes to Rs. 54,25,569/-(Rupees Fifty four lakhs Twenty five thousand Five hundred and Sixty Nine only) and scrap value of Unit 1&2 machines comes to Rs.1,08,50,892 (Rupees One Crore Eight Lakhs Fifty Thousand Eight Hundred and Ninety Two only). The Chief Engineer(Generation & PED) has sanctioned the Asset Decommissioning Note (ADN) and forwarded the Survey Reports for obtaining sanction for the disposal through e-auction.

The e-auction in KSEBL is a centralised scrap disposal mechanism, through which selected scrap items are being disposed through the web portal of M/s MSTC Limited, based on a Selling Agency Agreement executed between the Chief Engineer(SCM) & M/s MSTC Ltd. KSEBL had entered in to a long term agreement with M/s MSTC for the scrap disposal and the scope of e-auction in KSEBL had already been widened with addition of more scrap items with higher sale value for disposal and it is a faster, transparent and efficient method of conducting auction with wide participation of bidders registered with M/s MSTC Ltd. Therefore, sanction was requested as per note read as 5th above, for the disposal of the above items through e-auction through the O/o the Chief Engineer(SCM).

The matter was placed before the Full Time Directors as per note read as 6th paper above. Having considered the matter in detail, the Full Time Directors meeting held on 10-09-2021, resolved to accord sanction to dispose the old and unserviceable 18 MW, 11 kV, Generating units #1,#2,#3 Rade Koncar Make (Type S3105-8 BSS) available at Sholayar Power House, as per the Survey Reports through e-auction.

Further resolved to authorize the Chief Engineer(SCM) to carry out the above e-auction through M/sMSTC Ltd. Orders are issued accordingly.
