ORDER

The Government of Kerala had allotted 25 projects to the private developers through a competitive bidding process on BOOT basis for a period of 30 years in line the with Kerala SHEP Policy 2012. The Anakampoil SHEP (6.5MW) was one among them allotted to M/s Anakampoyil Power Pvt Ltd read as 1st above. The Implementation Agreement read as 2nd above was signed between Government of Kerala and the developer on 16.01.2015 , read as 2nd above. Later the project capacity was enhanced to 8MW based on the approval of Techno Economic Feasibility Report (TEFR) by GoK.

A common draft PPA format being followed by KSEBL for all SHEPs and got approved from KSERC in specific projects was forwarded by KSEBL to the developer on 23/03/2019, for initialing and submitting before KSERC. But the developer suggested many substantial modifications to the draft PPA format forwarded by KSEBL.

Several correspondences regarding modifications of clauses were done with the developer. The modified draft PPA as approved by the Full Time Director in its meeting held on 18.03.2021 read as 3rd above, incorporating the modifications requested by the developer and agreeable by KSEBL was forwarded to the developer as per letter read as 4th above. As per letter read as 5th above, M/s Anakampoyil Power Pvt Ltd has submitted the revised draft PPA after incorporation of the suggestions made by KSEBL, reserving their right to take up the issues related to the provisions regarding must run status, Tariff, Payment security mechanism, billing and payment, with the Hon'ble KSERC. M/s Anakampoil had requested to initial the revised PPA so as to enable them to approach the Hon'ble Commission for approval.

The developer has filed petition for approval of tariff for the power generated from 8MW Anakampoyil SHEP, before the Hon'ble Commission, for which the hearing is going on. The revised PPA forwarded by the developer has been verified and is in line with the standard PPA format given by KSEBL. Only after initialing a mutually acceptable PPA, both KSEBL and the developer can seek approval of KSERC .

The Chief Engineer(Commercial & Tariff) as per note read as 6th above has brought the matter to the attention of the Full Time Directors. Having considered the matter in detail, the Full Time Director in its meeting held on 12.08.2021,

- a) Resolved to accord sanction to initial the standard PPA for SHEPs , after incorporating the modifications in certain clauses requested by the developer, M/s Anakampoyil as approved by FTD and to handover to the developer for initialing at their end for submission to KSERC for approval.
- b) Further resolved to authorise the Chief Engineer(Commercial & Tariff) to initial the modified PPA as above.
