#### <u>ORDER</u>

The Dam Rehabilitation and Improvement Project under the World Bank assistance had come into effect on 18.04.2012. The Government as per Order read as 1<sup>st</sup> above accorded Administrative Sanction to the Kerala State Electricity Board Ltd. for the implementation of the rehabilitation of dams of 12 Hydro Electric Projects of KSEB under DRIP at an estimated cost of 25.41 Million US Dollar. KSEBL as per order read as 2<sup>nd</sup> above had adopted the above Government Order in Kerala State Electricity Board Ltd.

The tender for establishing instrumentation at 36 dams of KSEBL (in DRIP package) was invited as per Tender read as 5<sup>th</sup> above. The technical bid was opened on 19.12.2019 and only two bidders participated in the tender, viz.,

- 1..M/s Encardio-rite Electronics Pvt Ltd., A7 Industrial Estate, Talkatora Road, Lucknow,226011
- 2. M/s AIMIL LIMITED., Naimex house, 88/1,Outer Ring Road, Nagavara, Bangalore 560045

The technical offers from the bidders were found non responsive during the technical evaluation, especially for communication protocol. Hence it was decided to cancel the tender and re tender the work with revised tender specifications so as to get more offers.

The Central Project Monitoring Unit had issued concurrence for cancellation of the tender with the condition that the revised tender shall be prepared with adequate relaxation in prequalification criteria to encourage more participation and revised documents shall be submitted to CPMU at the earliest. In the 25th Technical Committee meeting, it was clarified that this procurement can be included in DRIP II. Now as the DRIP I works are over, the works allocated under DRIP II are to be initiated. The work of establishing instrumentation in 36 dams is to be re tendered, with modified specifications, as directed by the Central Project Management Unit, Central Water Commission.

As the modification of tender specifications requires expertise in the field of dam monitoring, instrumentation, electronics, communication etc., the service of an expert in this field is required. Hence the service of Sri. Aloushy Paul.C, Executive Engineer (Retd.) KSEBL, Cheradiyiel, (H). No.662/9, Idukki colony P.O, Vazhathope for preparing the new tender document is necessitated. He was associated with the O & M of instrumentation at Idukki project for many years, had attended National & International trainings and was also associated with the work of "Supply, Installation, Testing, Commissioning, Training and Maintenance of Real-Time Structural Health Monitoring & Early Warning System at Idukki dam". Also, he has expertise in the field of Electronics & Communication. A consolidated fee of Rs. 15,000/recommended to be paid for his service as above, for the preparation of bid document, incorporating modification of technical specification of instrumentation proposal and integration of data to the existing control rooms.

For the evaluation of the bid, it is proposed to form a Committee with the following members.

- 1. Chief Engineer (Civil-DS & DRIP)
- 2. Deputy Chief Engineer, Research&Dam Safety Organisation, Pallom
- 3. Technical expert
- 4. Executive Engineers, DRIP, R & DSO, R &DS Division Nos. I,- Kakkad /II, -Vazhathope / III, Idamalayar /IV, Pambla /V, -Thariode
- 5. AFO, Research & Dam Safety Organisation, Pallom.

The Chief Engineer (Civil-DS & DRIP) as per note read as 8<sup>th</sup> above has recommended to include Sri. Aloushy Paul.C, Executive Engineer (Retd.), KSEBL, as technical expert in the bid evaluation committee. Also recommended that technical advice may be sought from Sri. Aloushy Paul.C, Executive Engineer (Retd.), KSEBL, during the contract period of instrumentation and installation of surveillance system in dams. Sri. Aloushy Paul.C was contacted as per letter read as 6<sup>th</sup> above and he has conveyed his willingness as per letter read as 7<sup>th</sup> above to render his service to KSEB Limited. The Chief Engineer (Civil-DS & DRIP) has recommended as per letter read as 8<sup>th</sup> above, to pay Sri. Aloushy Paul.C, Executive

Engineer (Retd.), KSEBL a consultation fee @ Rs. 5000/- per sitting /inspection in addition to the TA &DA at the applicable rates eligible for Grade I officers of KSEBL.

The matter was placed before the Full Time Directors as per note read as 9<sup>th</sup> above. Having considered the matter in detail, the Full Time Directors in the meeting held on 12.08.2021

- Resolved to accord sanction to entrust Sri. Aloushy Paul.C, Retd Executive Engineer (KSEBL), Cheradiyiel, (H). No.662/9, Idukki colony P.O, Vazhathope, PIN 685602, with the task of modification of technical specification of instrumentation proposal of KSEBL dams and integration of data to the existing control rooms, to incorporate in the bid documents, a consolidated fee of Rs. 15,000/- (Rupees Fifteen Thousand only) shall be paid to him (one time).
- 2. Further resolved to include Sri. Aloushy Paul.C, Retd. Executive Engineer (KSEBL), Cheradiyiel, (H). No. 662/9, Idukki colony P.O, Vazhathope, PIN 685602, as technical expert in the Committee for the evaluation of the bid and for providing technical advice during the implementation of Instrumentation and Surveillance system in dams during the contract period with a consultation fee @ Rs. 5000/- per sitting/inspection in addition to the TA & DA at the applicable rates eligible for Grade I officers of KSEBL.
