As per Board Order read as 1st above one guest player can be engaged for the Volleyball (Men) team for maintaining the minimum strength required for participation in tournaments. The guest players are eligible for a Monthly allowance of Rs.3,000/-, Daily allowance @ Rs.100/- per day (for outstation players) & @ Rs.75/- per day (for local guest players) and Diet allowance @ Rs.50/- per session during the period of their engagement as per Board Orders read as 2nd & 3rd above.

The Sports Co-ordinator as per note read above has recommended to consider the request to engage Sri.Shibin J S as guest player of the KSEB Volleyball (Men) team since there is no one to play in the position of libero in the team.

Having considered the matter in detail, the Full Time Directors in its meeting held on 12-08-2021,

Resolved to accord sanction for the engagement of Sri.Shibin J S, Volleyball player as guest player of the KSEB Volleyball (Men) team for a period 90 days w.e.f. 10th August 2021 or till the recruitment of new players in the team, whichever is earlier.

The guest player engaged as above shall have no claim for regular establishment in Kerala State Electricity Board Limited.


