ABSTRACT

ORDER

The Chief Engineer, Transmission South, as per note read as 1st above, requested sanction against detailed estimate for issuing Demand note to M/s. Metrolla Steels Pvt. Ltd who had requested 5MVA power allocation at 33 kV voltage level from 110 kV Sub Station, Muvattupuzha. The power is requested for their Continuous Casting Division at Mulavoor Village, Paipra in Electrical Section, Velloorkunnam under Electrical Division, Muvattupuzha under deposit work.

Considering the power feasibility to be provided to M/s. Metrolla Steels Pvt. Ltd., an additional 16MVA, 110/33 kV transformer is proposed to be installed at 110 kV Substation, Muvattupuzha and the pro-rata amount towards the cost of installation of 16 MVA Transformer along with the transformer & feeder bays and allied yard equipments is to be collected from the party.

The total Estimate amount is Rs. 5.5 Cr. (including GST). Out of the Rs.5.5 Cr., the amount to be remitted by the firm is Rs. 1,96,37,571/- (including GST) . This includes pro-rata amount of Rs. 75,12,488/- +18% GST (for installation of 16MVA transformer & allied works) , Rs. 76,53,191/- +18% GST (for construction of 33kV feeder bays with allied works & civil works) and Rs. 14,76,330/- +18% GST (for supervision charges in connection with the cable laying work & allied works in the premises of M/s. Metrolla Steels Pvt. Ltd.).

The Chief Engineer, Transmission South had submitted a proposal for getting Administrative Sanction as per note read as 1st above an estimate amounts to Rs. 5.5 Cr. under Deposit Work for providing 5 MVA power as requested by M/s. Metrolla Steels Pvt. Ltd., Paipra, Muvattupuzha from 110 kV Substation, Muvattupuzha.

The estimates are prepared based on transmission cost data dated 13.07.2021 and labour data for Transmission Line construction dated 13.04.2020 and civil data based on DSR 2016.

As per the Clause no. 8.1 of Delegation of powers of Executive officers dated 25.04.2017, the FTD is authorised to grant Administrative Sanction to Deposit works > 5 Cr.

The matter was placed before the Full Time Directors as per note read as 2rd above.

Having considered the above, the Full Time Directors in the meeting held on 12.08.2021,

Resolved to accord Administrative Sanction for an amount of Rs. 5.5 Crore (Rupees Five Crore and Fifty lakhs only) for the work of Supply of Power to the extent of 5MVA to M/s Metrolla Steels Pvt. Ltd., Paipra, Muvattupuzha under Transmission Circle, Thodupuzha subject to condition that the part of the deposit work amount of Rs. 1,96,37,571/- (including GST) will be borne by M/s. Metrolla Steels Pvt. Ltd. which includes pro-rata amount for installation of 16MVA transformer, cost of construction 33kV feeder bays & civil works and the supervision charges of the cable laying work and allied works in the premises of M/s. Metrolla Steels Pvt. Ltd.

Orders are issued accordingly.
