ABSTRACT

Administrative Sanction for procuring Net meters for Soura Phase II subsidy scheme - Order Issued

ORDER

The MNRE launched the Phase II Grid connected Roof Top Solar subsidy programme for domestic sector towards achieving cumulative capacity of 40 GW from Roof Top Solar (RTS) project by the year 2022. Accordingly KSEBL was allocated 50 MW for the year 2019-20 on 20.8.2019 and 200 MW for the year 2020-21 on 24.11.2020 in subsidy scheme. KSEBL had started registration for domestic consumers in Phase II subsidy scheme. Almost 21,000 consumers are already registered for installing roof top solar power plants and the registration is continuing.

As per the Renewable Energy and Net Metering Regulation 2020 of Kerala State Regulatory Commission, DISCOMS has to provide the bi- directional meters to the consumers (Chapter III Clause 16.3). Also, the bench mark cost published by MNRE excludes the net metering cost. (Office Memorandum dated 21.07.2020 point no. 3 of MNRE). Hence the supply of net meter is not in the scope of the developers.

The State Nodal officer , Soura as per the note read above informed that in order to ensure timely completion of the project, it is required to procure 25,000 numbers of bi- directional whole current meters (15000 single phase and 10000 three phase). The financial commitment will be approximately Rs. 6,34,94,000/- (Rupees Six Crores Thirty Four Lakhs Ninety Four Thousand only).

Having considered the matter in detail, the Full Time Directors in its meeting held on 12.08.2021

- 1) Resolved to accord sanction for procurement of 25000 net meters (15000 Single Phase and 10000 Three Phase) for providing to the consumers in the Soura Phase II Subsidy Scheme. The total financial commitment would be approximately Rs.6.35 Crores (Rupees Six Crores Thirty Five Lakhs Only)
- 2) Further resolved to authorize the Chief Engineer (SCM) to invite tenders for the procurement of the net meters, for Soura Phase II Subsidy Scheme.

Orders are issued accordingly.
