As per the terms and conditions of the Purchase Order, Supply shall commence on the  $3^{\rm rd}$  month and complete on the  $6^{\rm th}$  month from the date of Purchase Order as detailed below:

As per letter read as 4<sup>th</sup> above, the firm requested time extension.

The Proto inspection call for D3, D30 & D60 towers were received on 11/02/2020. But due to Covid pandemic proto inspection was cancelled and inspection on D3, D30, D60 & Q type towers were waived on 17/03/2020. The mass inspection call for D3, D30, D60 towers were received on 04/06/2020 and inspection was conducted through video conference based on the test report received on 26/06/2020 and MDCC issued on 01/07/2020 from these tower.

The firm submitted the drawing for towers (P, Q, R, S, M3, M30, M60 and Z) only after 25/05/2020. Also there is no delay in drawing approval and conducting inspection and issuing of MDCC as per purchase order conditions for these towers, so the request for delivery extension of all item for three months can be considered only based on the COVID - 19 situation.

As per Force Majeure conditions of Purchase Order Clause -19:- The firm will not be liable for any liquidated damages for such delay due to force majeure conditions such as acts of God, acts of force majeure conditions. The KSEB Limited will verify the facts on merits and grant suitable extension of delivery period if facts justify.

It is notified by the Ministry of Finance, Government of India as per Memorandum read as 2<sup>nd</sup> above that COVID-19 situation should be considered as a case of natural calamity and FMC may be evoked, wherever considered appropriate. As per Memorandum read as 3<sup>rd</sup> above, it is clarified that it may not be possible for the parties to the contract to fulfill contractual obligations due to the restrictions placed on the movement of goods, services and manpower on account of the overseas, countrywide lockdown in terms of guidelines issued under DM Act 2005. The date for completion of contractual obligations which had to be completed on or after 20<sup>th</sup> February 2020 shall stand extended for a period not less than three months and not more than six months without imposition of any cost or penalty on the contract.

Hence the request of the firm for extending delivery period for all towers its sub and extensions, for 3 months i.e., Commence on 6<sup>th</sup> month and complete on the 9<sup>th</sup> month from the date of purchase order is genuine and can be considered.

It is recommended to consider the Delivery Period extension of M/s.Karam Tara Engineering Private Limited commence from 6<sup>th</sup> month instead of 3<sup>rd</sup> month and complete on 9<sup>th</sup> month instead of 6<sup>th</sup> month from the date of purchase order for the following items as shown below without imposing penalty on LD and with variable price as per actual date of receipt of materials by consignee as it is genuine due to Covid-19 pandemic which comes under Force Majeure Conditions.
