ORDER

The construction of Edamon–Kochi 400kV Transmission Line passing through 4 districts viz, Ernakulam, Kottayam, Pathanamthitta and Kollam, having 148.3km length and 447 towers, which has been completed and the line energized on 25.09.2019. The disbursement of compensation for Tower Standing Area(TSA), Line Corridor and Trees/Crops damages are in progress. The Detailed Valuation Statement (DVS) for 427 tower locations (819 holdings) for an amount of Rs. 43.106Cr. and DVS for 305 spans 3703 holdings for an amount Rs. 118.688 Cr. for line corridor compensation has been approved by the District Collectors as on 30.06.2021 . An amount of Rs. 38.606 Cr. has been disbursed to 682 land owners towards TSA compensation by LA Units at 4 districts. The Compensation for trees & crops are issuing exclusively by PGCIL. Also an amount of Rs. 21.917 Cr. has been disbursed among 798 land holders as line corridor compensation.

The status of the assessment of compensation, disbursement of compensation and the particulars of the fund deposited by PGCIL , KSEBL etc. as on 30.06.2021 are detailed below.

- An amount of 34 Crores had been deposited as on date by KSEBL towards Line Corridor compensation out of the total KSEBL/GoK share of Rs. 74.18 Crores and an amount of Rs. 40.18 Cr. was to be deposited as on 30.06.2021.
- An amount of 6 Crores had been deposited as on date by KSEBL towards TSA compensation out of the total KSEBL/GoK share of Rs. 6.466 Crores and an amount of Rs. 0.466 Crores is to be deposited as on 30.06.2021.
- As per clause X of the G.O.(MS.) No. 29/2015/PD Dated 30.07.2015, "In the first instance, the amount for implementing the special compensation package will be met by KSEB by availing loan. Government share will be granted subsequently". Accordingly KSEBL had deposited an amount of Rs 40 Cr. (KSEBL share + GoK share) to the compensation account as on date. An amount of Rs. 3 Cr. out of 20 Cr. had been received from Government of Kerala as per GO read as 7th above through fund re-appropriation and Rs. 17 Cr. is to be received from GoK as the share of Line Corridor and TSA compensations.
- Also as per Board Order read as 5th above, an amount of Rs. 155 Cr. is estimated as KSEBL's share and allocated for the purpose .

In view of the above, the Director(Transmission & System Operation) has recommended to allocate an amount of Rs. 40.646 Cr. from KSEB fund for disbursement of the special compensation package for line corridor part and TSA part, and the same may be transferred immediately to the Compensation Disbursement Accounts of "Edamon -Kochi Project" through ARU of Transmission Division Pathanamthitta. Accordingly the GoK share will be 37.323 Cr. (17 Cr. + 20.323 Cr.).

Having considered the matter in detail, the Full Time Directors in the meeting held on 12.08.2021,

1. Resolved to accord sanction to allocate an amount of Rs. 40.646 Cr. (Rupees Forty Crore Sixty Four Lakhs and Sixty thousand only) from KSEBL fund as per the Board Order dated 07.05.2018 for disbursement of the special compensation package for line corridor part and to transfer the amount to the Compensation Disbursement Accounts of " Edamon - Kochi Project" through ARU of Transmission Division, Pathanamthitta.
2. Further resolved to request the Government to allocate their share of Rs. 37.323 Cr. (17 Cr. - earlier shares + 20.323 Cr. - present share) on the above for meeting subsequent payments required in this regard.

Orders are issued accordingly.
