ORDER

KSEB Ltd as per B.O read as 1st above has accorded Revised Administrative Sanction for the implementation of the Upper Sengulam Hydro Electric Project at an estimated cost of Rs 276.20 Crore. The Upper Sengulam Sub Division office is formed for the implementation of the subject Scheme.

The Chief Engineer(Civil Construction) South as per note read as 2nd above has reported that at present only one departmental diesel jeep bearing Reg. No. KL 06-65, 1989 model Mahindra is allotted to the Upper Sengulam Sub Division office with a driver on contract basis. The vehicle is more than 31 years old and frequent maintenance is required to keep the vehicle road worthy. The maintenance and running cost of the 1989 model diesel jeep is comparatively high. Hence the Chief Engineer(Civil Construction) South has issued sanction to survey report this jeep.

It is further reported that a road worthy vehicle is essential for attending the land acquisition works and smooth functioning of the office. Hence the Chief Engineer requested sanction for hiring a jeep on contract basis for the use of Upper Sengulam Sub Division office with monthly limit of 1500 km.

The matter was placed before the Full Time Directors as per note read as 3rd above.

Having considered the matter in detail, the Full Time Directors in its meeting held on 12.08.2021 resolved to accord sanction for hiring a jeep on contract basis with monthly limit of 1500 km for the use at Upper Sengulam Sub Division office by observing all formalities.
