ORDER

M/s P.V. Sadasiva Cinema bearing consumer code 6/6759 is an HT consumer having Contract Demand of 70 kVA under Electrical Circle, Tirur.

The service connection of the above mentioned consumer was disconnected on 11/11/2019 due to default in payment of current charges and

consequently dismantling notice was served as per Regulation 139(6) of the Kerala Electricity Supply Code 2014 as per letter read as 1st above. Later the Deputy Chief Engineer, Electrical Circle, Tirur as per letter read as 3rd above has informed that the above HT service connection is deemed to be dismantled as on 24/12/2020 since the premises is locked up and physical dismantling of electric connection could not be carried out.

As per the letter read as 4th above, the consumer has intimated that the theatre is kept closed during lockdown in connection with Covid 19 Pandemic. After remitting ₹.50,000/- on 13/01/2021, the consumer has requested to allow some more time for the payment of balance current charge arrear due to KSEBL.

Meanwhile as per letter read as 5th above, the Deputy Chief Engineer, Electrical Circle, Tirur has reported that the dismantling notice sent to the consumer was returned citing 'addressee not found' and hence the notice was pasted on the premises of the consumer. Now, the Deputy Chief Engineer, Electrical Circle, Tirur has recommended to consider the request of the consumer read as 4th above for installment facility. The consumer has also stated that he will remit ₹.1,00,000/- after the lockdown period and further requested for 12 installments for remitting the remaining arrears. As such the consumer has remitted ₹.1,00,000/- on 18/06/2021 as stated in his request. The outstanding current charges due from the consumer are detailed below.

Current Charges from September 2020 to May 2021	₹. 1,63,240/-
Total Current Charges outstanding	₹. 8,65,845/-
Security Deposit Available as cash	₹. 2,46,750/-

The matter was taken up with the Director (Finance) vide note read as 6th, wherein it was directed to put up the matter before the Full Time Directors. Accordingly, the matter was placed before the Full Time Directors as per note read as 7th above.

Having considered the matter in detail, the Full Time Directors in the meeting held on 04/08/2021 resolved to accord sanction to allow the consumer M/s P.V. Sadasiva Cinema (LCN 6/6759) 6 monthly installments and to effect reconnection after the payment of first installment by considering his request

on humanitarian ground and remittance of ₹.1,00,000/- in the present Covid-19 induced situation.

Orders are issued accordingly.
