ABSTRACT

320kV HVDC Pugalur- Thrissur transmission line- Compensation to be given as per the Special compensation package for the Tower Standing Area– Sanctioned- Orders issued.

ORDER

The Special compensation package for the construction of Pugalur-Thrissur line and for the LILO construction of Thrissur to Kochi was announced as per Government orders read as 2nd and 3rd above.

The approximate estimate for the compensation to be paid in accordance with the orders read as 2nd and 3rd above was worked as ₹ 45 cr. (approx.) and KSEBL as per order read as 4th above accorded sanction to allocate an amount of ₹ 13.87 cr. (approx.) as the share of KSEBL towards the compensation for Pugalur-Thrissur line, presuming 50:50 sharing of expense by KSEBL/Government of Kerala (GoK)

The Executive Engineer, Transmission Division, Chittur who has been entrusted with the task of coordinating compensation disbursement from KSEBL side in the case of Pugalur-Thrissur line reported as per letter read as 8th above that the Tahsildar, LA, Power Grid, Palakkad had intimated that an amount of ₹ 40,17,569/- has been disbursed as compensation for Tower Standing Area of

the 139 towers of the 320 kV HVDC Pugalur Thrissur transmission line (Kerala portion). The Tahsildar had further informed that 15% of the disbursed amount (ie. ₹ 6,02,638/-) is the share of KSEBL and the amount has to be remitted to the account of the Special Tahsildar, LA, Powergrid, Canara Bank, Sulthanpetta (A/c No. 0812101071441, IFSC code CNRB0000812).

As per the compensation package, 85% of the compensation for the Tower Standing Area is to be paid by PGCIL and the rest by KSEBL / GoK, which means that 15% is the share of KSEBL & GoK. The Government of Kerala as per order read as 6th above clarified that the financial liability due to the special compensation package shall be shared equally between GoK and KSEBL, but whether KSEBL has to remit the share of GoK as well in the first instance, as in the case of Edamon-Kochi compensation package, is not mentioned. A decision on the amount to be remitted by KSEBL towards the compensation was sought from the Full Time Directors as per note read as 9th above.

Having considered the above, the Full Time Directors, in the meeting held on 4.08.2021, resolved to transfer the amount of Rs. 6,02,638/- to the account of the Special Tahsildar, LA, Powergrid, Canara Bank, Sulthanpetta (A/c No. 0812101071441, IFSC code CNRB0000812) as the share of KSEBL and Government of Kerala towards the compensation for the TSA and to request the Government of Kerala to transfer the said amount to KSEBL as early as possible.

Further resolved to authorize the Financial Adviser to transfer the approved amount to the ARU of Transmission Circle, Palakkad after allocating a separate account head for "Compensation for Pugalur-Thrissur HVDC line".

Orders are issued accordingly.
