Shifting of existing LT OH line passing above the newly constructed house of Smt.Nithya under Electrical Section, Thiruvegapura- Sanction for carrying out the work using Board's fund- Sanctioned - Orders issued.

ORDER

The Deputy Chief Engineer, Electrical Circle, Shoranur as per letter read as 1st above has reported that Smt. Nithya, Pattambi, had applied for electric connection to her newly constructed house under Electrical Section Thiruvegapura on 26.02.2021. On site inspection, it was found that the LT single phase line passing above her house is to be shifted for effecting the service connection to Smt. Nithya. She had also applied in the Vydyuthi Adalath for shifting the line to the side of the land, due to her poor financial condition. But she failed to attend the adalath due to feeding baby at that time. The applicant belongs to BPL and SC category and acquired house through the scheme of SC/ST by the Government.

An estimate amounting to Rs 35098/- is required for shifting of existing LT line. The length of the existing LT 1 phase, OH line is 40 m, while that of the proposed new route will be increased by 15m and would necessitate erection of 3 nos additional LT poles with stay and 35 m ACSR Conductor for suitable realignment of LT line .

The matter was placed before the Full Time Directors as per note read as 3rd above for a decision.

Having considered the matter in detail, the Full Time Directors in the meeting held on 04.08.2021, resolved to accord sanction to the Deputy Chief Engineer, Electrical Circle, Shornur for carrying out the work of "shifting of existing LT line to the side of the land" in favour of Smt.Nithya who belongs to BPL category under Electrical Section, Thiruvegapura using Board's fund, considering the financial constraints of the complainant and safety issues in the area, as a special case

Orders are issued accordingly.
