### ORDER

The single part e-tender for the procurement of 5 sets of 110V 15 A, 20 sets of 110 V 30 A and 4 sets of 110 V 60 A Battery Chargers on FIXED price basis was invited as per e-tender read as 2<sup>nd</sup> above based on the requirement as per Purchase Plan 2020-21. The Chairman and Managing Director has directed in the note read as 4<sup>th</sup> above to re-tender the items. Hence the tender was cancelled and the items were re-tendered by adding the quantity required as per PP 2021-22 also.

Single part e-tender for the procurement of 12 sets of 110V 15 A, 35 sets of 110 V 30 A and 10 sets of 110 V 60 A Battery Chargers on FIXED price basis was invited as per e-tender read as 5<sup>th</sup> above based on the requirement as per Purchase Plans 2020 -21 & 2021-22, as per B.Os read as 1<sup>st</sup> & 3<sup>rd</sup> above with the Probable Amount of Contract as Rs.58,55,000/-.

The bid was opened on 19/02/2021. Five bidders viz. M/s Banavathy Power Systems Pvt. Ltd., M/s N.G. Corporate Solutions, M/s Voltec Manufacturing Company Limited, M/s Waves Electronics Pvt. Ltd. and M/s Chloride Power Systems & Solutions Ltd. had quoted. The offer of M/s. Chloride Power Systems & Solutions Ltd. was rejected. The bids of the other four bidders were evaluated.

M/s Voltec Manufacturing Company Limited and M/s Waves Electronics Pvt. Ltd have technically qualified for the tender. The lowest price for 110 V, 15 A Battery Charger is quoted by M/s Voltec Manufacturing Company Limited and the lowest price for 110 V 30 A & 110 V 60 A Battery Chargers is quoted by M/s Waves Electronics Pvt. Ltd. For 110 V, 15 A Battery Charger the total quantity to be procured is 12 Nos. As per tender condition 10% quantity is applicable for new Entrant. Also for new entrant factory inspection is mandatory. But due to the travel restrictions in connection with lock down imposed against the spread of covid-19 pandemic, it is not possible to conduct inspection and hence the standards of the factory cannot be ascertained. M/s Voltec Manufacturing Company Limited is only eligible for a meagre quantity of 1 No to be given, the offer of the firm for the meagre quantity need not be considered.

Hence the evaluation was proceeded with L1 bidder, M/s Waves Electronics Pvt. Ltd., Ernakulam who was the previous supplier of the items with good records of performance.

The financial commitment of the purchase with M/s Waves Electronics Pvt. Ltd., Ernakulam, (L1) for 12 sets of 110 V 15 A Battery Charger is Rs.13,77,768/-, 35 sets of 110 V 30 A Battery Charger is Rs.45,01,700/- and 10 sets of 110 V 60 A Battery Charger is 17,32,240/- . The total financial commitment of M/s Waves Electronics Pvt. Ltd comes to Rs.76,11,708/- (Rupees Seventy Six Lakh Eleven Thousand Seven Hundred and Eight only).

The matter was submitted before the Director (G-E & SCM) as per note read 9 above. It was directed to place the matter before the Full Time Directors.

Accordingly the matter was submitted before the Full Time Directors as per note read as 10<sup>th</sup> above.

Having considered the matter in detail the Full Time Directors in the meeting held on 04.08.2021 resolved to accord sanction for placing Purchase Order for 12 sets of 110 V 15 A @ unit AIR of Rs.1,14,814/-, 35 sets of 110 V 30 A @ unit AIR of Rs.1,28,620/- and 10 sets of 110 V 60 A Battery Chargers @ unit AIR of Rs.1,73,224/- with M/s Waves Electronics Pvt. Ltd, the L1 bidder; considering the acute shortage of Battery Chargers in field. The total financial commitment is Rs.76,11,708/- (Rupees Seventy Six Lakh Eleven Thousand Seven Hundred and Eight only).

Orders are issued accordingly.
