ORDER

The monthly kilometer limit of the car hired with driver for the official trips of the Project Manager, Vellathooval and Chinnar HE Projects, was fixed as 1500 km, as per Board order read as 1st above and this was later enhanced to 2000km for a period of one year, as per Board order read as 2nd above.

Now the tunnel lining works are in progress, both from the intake side and from the exit side in three shifts and the daily site inspection is to be intensified accordingly. The construction activities are in full swing at the two work sites which are 5 km apart. The Project Office and the Circle office are respectively 14 km and 13 km away from the work site. In connection with the land related issues also, it becomes necessary to visit the Taluk Office and Collectorate at least once in a month. Besides, the site visit of Officers from the Design Wing and the Geotechnical Investigation Office are also being carried out using this vehicle. The travel for monitoring of complaints arising from the public in the tunneling route, attending cases at the Hon. High Court, Kochi etc. are also often necessitated. In addition, the tender for phase-II power House construction is also now floated.

On account of the aforesaid reasons the Chief Engineer (Civil- Investigation & Construction Central) as per letter read as 3rd above has requested extension of enhanced monthly km limit of the hired vehicle of the Project Manager, Chinnar SHEP at 2000 km for a further period of one year with effect from 01.09.2021.

The proposal was placed before the Full Time Directors as per note read as 4th above. Having considered the matter in detail, the Full Time Directors in the meeting held on 04.08.2021 resolved to accord sanction for the extension of the monthly kilometre limit of the hired vehicle of the Project Manager(Vellathooval & Chinnar HE) at 2000 km for a further period of one year with effect from 01.09.2021.

Orders are issued accordingly.
